- In this case, the affect is prolonged, intensifying and attacks and resets mental endurance.
- Affect in this specific case narrows the field of consciousness, seeks to conquer it completely and displace everything else from it.
- -The problem here is that affect leads to a real escape from reality, but there is nowhere to go, there is no salvation.
- Affect in this specific case erases sensitivity in a person. His senses do not function, they make mistakes.
- The affect of fear completely paralyzes thinking.
- The affect suppresses the will. The person becomes impulsive in his actions, The person is manipulated by propaganda and the media.
- The affect causes illogical thinking.

Fear develops at all levels of consciousness, of the subconscious,

Fear also develops at all levels of needs.

So fear is a very unpleasant feeling and a very primary emotion that arises in an animal or a person naturally, spontaneously, at the slightest perception of danger or harm. The physical process that unleashes fear is located in the human brain and it causes immediate physical manifestations such as - increased blood pressure, increased blood glucose, palpitations, dizziness, lack of air, a feeling of helplessness, fear of death, fear of going crazy, real loss of control of reactions.

Manipulators find the weak point in people – the fear of death, the fear of infection, an increased fear of getting infected, so that they don't die.
- There is no trust here and it is not aimed at, since it is actually a threat to people's health and life.
- Here, the aim is to create a sense of duty both to oneself and to other people.
- This is done unconsciously.
- Continuous repetition, repeated repetition, aims at zombifying the population.
- All this happens at a subconscious level. The aim is control, management of people's will.
- There is actually mass manipulation of consciousness.
- Manipulation makes real and causes a change in people's perceptions and behavior.
- The tactic is hidden, violent.
- Through manipulation, the aim is to manage people's behavior towards fear, threats, stress. People are not really given the opportunity to think, to draw conclusions, to analyze data, facts, evidence.

- The continuous repetition aims to create trust, belief that the actions and decisions of institutions are correct.
- There is really a psychological impact, psychological violence on the consciousness, actions, behavior, reactions of people.

- In reality, the goal of manipulation is the value system, beliefs, stereotypes and their real neglect, zeroing in this process.
- In reality, people are deprived of freedom of their choice, of any choice, people are deprived of their free will. In reality, people are disoriented.
- In this manipulation, not only media, print, but also all information channels - the Internet, etc. are used.
- In reality, the coercion of manipulation has been achieved.
- Manipulation leads to the conclusion that this is **EVERYTHING IS NATURAL AND INEVITABLE**.
- In this short and massive process of manipulation, people do not have time to doubt the messages, the data, the facts.
- In reality, manipulation hides aggressive intentions and behavior.
- In reality, manipulators know the psychological vulnerabilities of people.
- Manipulators do not worry at all about the damage, moral, emotional, psychological, behavioral and others to people.
- In reality, there is deception by default.
- Manipulators do not give any direct answers, scientifically substantiated, manipulation and manipulation occurs through threats.
- They increase fear and uncertainty.
- The goal is unconditional obedience.
- The goal is obedience, and the implementation of any actions and measures
- The resistance of people's consciousness to think, discuss, evaluate data, facts, evidence is actually eliminated.
- The goal is confusion, through accusations.
- Manipulation uses anger, fear, threats.

The World Health Organization was formed in 1948. and is a special agency of the UN. The WHO emblem shows the snake Moses wrapped around a wheel, a symbol of the "all-seeing eye", on the image is a flat earth surrounded by two ears of wheat, a symbol of the harvest Harvest and 9 people.

In each ear of wheat there are 13 elements, a symbol of the 13 "Israelite tribes". These are 13 Illuminati families.

The 63rd World Health Assembly, prepared by the Secretariat and the World Health Organization, selectively reports voluntary donations for 2008-2009.

According to this report, the US government has received 424.5 million US dollars, and the Bill and Melinda Gates Foundation - 338.7 million US dollars.

Donors to the "Global Alliance for Vaccination and Immunization" GAVI with 85 million US dollars is the Gates Foundation, the Gates Foundation has donated more than 1.14 billion US dollars from 1999 to 2009. . While the US government has donated only 569 million US dollars for the years 2001-2009.

For 30 years, human rights organizations and various other activists have accused UNICEF and the World Health Organization of a planned campaign to sterilize the population in various countries using vaccines for various diseases.

For example, in 1993, a scientist from the Innsbruck Institute for Biometric Research of the Austrian Academy of Sciences and scientists from the World Health Organization developed birth control vaccines.

In 2004, Nigeria boycotted a vaccine produced specifically for sterilization.

The main organizers were the World Health Organization and the European Commission.

THE TAKING OF DAYS, RNA TECHNOLOGY, NANOTECHNOLOGIES

Everyone will be connected to the 5G network with supercomputers that will control and manage them. In this way, there will be continuous control over their personality and life. The chip will transmit all data about the personality. Through nanoparticles or nano pots, it

will be possible to control every part of the human body and change DNA through the 5G network. The chip will receive frequencies emitted by the network 24 - 90 Giga Hertz. Separately, the European Commission has already reached an agreement with Bill Gates and has collected the sum of 8 billion euros, . .i. Bill Gates and the Pentagon will make huge profits with the funding.

The initial development of CELLECTRA 3PSP began back in 2019 with a grant of 8.1 million US dollars from the medical branch of the Medical CBRN Defense Consortium U.S. Defense Threat Reduction Agency (DTRA).

The coronavirus was created back in 2015 in the US national laboratory + Galveston” at the University of Texas.

7/. DOMINATION AND CONTROL OF THE HEALTH, NATIONAL, POLITICAL SOVEREIGNTY OF EVERY STATE THROUGH THE WORLD HEALTH ORGANIZATION

The Goal is DICTATION, DICTATORSHIP, GENOCIDE And Implementation of The Plan TO IMPOSE WORLD ORDER Through A Supranational Organization, Whose Plans, Agreements, Etc. TO BE OBLIGATORY FOR EVERY STATE.

77th World Health Assembly of the World Health Organization 27-05-2024 – 01.06.2024

That is why the WHO is also creating the so-called IHR (International Health Regulations), which are currently being negotiated during the 77th World Health Assembly of the World Health Organization from 27.05.2024 to 01.06.2024.

Previously, negotiations between the WHO and the black countries on the PANDEMIC INSTRUMENT were frozen.

THE PLAN and STEPS to impose a SUPRANATIONAL ORGANIZATION to govern all countries to start a PANDEMIC and to IMPLEMENT THE PLANS OF THE DEEP MAFIA.

PROCEDURES

WHO Member States agree to Decision 150(3) of the Executive Board (2022) and Decision WHA75(9) (2022) of the World Health Assembly and begin a process to amend the current International Health Regulations (2005) (IHR).

This is done in parallel with the negotiation process for the preparation of a pandemic instrument.

The negotiations for the pandemic instrument and the entire process are led by WHO Member States.

The competent authority for each country is the respective Ministry of Health.

The negotiations discuss the following key terms as follows in the period 22-26 April 2024.

- “early warning signal”

This signal is given by the Director-General of WHO alone to all Member States. That is, the procedure is activated upon a single signal.

“event”. This is an indication of the manifestation of a disease or a circumstance that creates the potential for disease. It is not discussed here whether there is an actual manifestation of a disease.

- “sick person” means an individual suffering from or affected by a physical condition that may pose a risk to public health. Everything depends on the free interpretation of the Director-General of WHO.
- “National IHR Authority” means the entity designated or established by the State at the national level to coordinate the implementation of these Regulations within its territory. This means that this

administration will be specialized and will be established at the request and initiative of WHO.

- "National IHR Focal Point" means the national center designated by each State, which will be available for communications with the WHO IHR Contact Points in accordance with these Regulations. The connection will be direct with the WHO, without any national mediation.

THE POWERS OF THE WHO DIRECTOR-GENERAL, which prove the REJECTION OF HEALTH SOVEREIGNTY, NATIONAL SOVEREIGNTY, NATIONAL SECURITY AUTHORITIES, and POLITICAL SOVEREIGNTY, NATIONAL SOVEREIGNTY, PUBLIC SOVEREIGNTY, SOVEREIGNTY guaranteeing human rights and freedoms

- The Director-General of WHO has the following powers, which GUARANTEE UNIFORM MANAGEMENT OF ALL PROCEDURES AND DIRECTIVES AND UNDERSTANDINGS WHICH ARE BINDING ON EACH STATE
 - Determine for the Member States in whose territory the event occurs whether it constitutes an emergency or a pandemic in accordance with the criteria and procedure set out in the new health regulations
 - If the Director-General of WHO and the Member States do not reach a consensus within 48 hours on whether the event constitutes an emergency, the procedure under Article 49 shall apply to the disagreeing State.

This includes convening the Emergency Committee and making binding recommendations to the non-compliant country

- If the Director-General of WHO determines that there is a public health emergency of international concern in the relevant country or countries, including a pandemic, WHO, under the orders of the Director-General, can mobilize international assistance on the spot - i.e. international forces and forces from other countries, subordinate to the Director-General of WHO DIRECTLY.

At the same time, the Member State must respond to such a proposal as soon as possible, including the reasons for the response.

THIS PROVES that WHO can enter the relevant country without its consent and do whatever it wants in that country.

THIS IS DOMINATION OF THE COUNTRY WITHOUT ANY SANCTIONS, WITHOUT REQUIRING THE CONSENT OF THE COUNTRY IN QUESTION.

- According to Article 12, the Director-General of WHO issues temporary recommendations based on Article 49, which can be amended or extended.

These recommendations can be issued additional temporary recommendations after the end of the pandemic. That is, at the DISCRETION OF THE DIRECTOR-GENERAL, WHO CAN DO WHATEVER IT WANT IN THE RELEVANT STATE or RELEVANT STATES, IGNORED ANY SOVEREIGNTY OF THAT STATE, IGNORED CONSTITUTIONS, LAWS OF THE RELEVANT STATES.

The national authorities of the respective countries are waiting for the Secretary-General of WHO to determine all actions and for him to determine whether the pandemic has passed or not. He is the one who decides this, no institution of the respective country.

THIS IS A REAL DICTATORSHIP and UNCONDITIONAL DICTATORSHIP and UNCONDITIONAL DICTATORSHIP .

- The measures that are imposed according to the procedure under Art.49 cannot be canceled earlier than 3 months after their announcement. DURING THIS TIME THE DIRECTOR GENERAL and WHO REALLY GOVERN EVERYONE AND EVERYTHING IN ONE COUNTRY WITHOUT ANY EXPLANATIONS, IN VIOLATION OF ANY STATE LAWS, CONSTITUTION.

During this time, the WHO's go-to party can announce QUARANTINES, LOCKDOWNS, all kinds of masks, tests, restrictions, the demand for a certificate, EVEN VACCINATION - FORCED.

- Along with the "standard measures", which include any restrictions - mostly coercive ones.
- The Director-General of the WHO has the authority to impose restrictions, in the presence of two specific criteria in emergency situations.

Then they can be used by the Director-General of the WHO and other international organizations and bodies, at his DISCRETION, EVEN MILITARY BODIES and OTHERS to IMPOSE THE MEASURES and ACTIONS THAT THE DIRECTOR-GENERAL ORDERED.

- In accordance with Article 12, the Director-General shall assess the availability and accessibility of health products required to respond to a public emergency.

I.E. THIS MEANS THAT THE DIRECTOR-GENERAL PERSONALLY DETERMINES THE TREATMENT, MEASURES, IMPACT and IMPOSITION OF VACCINATION.

WHO surveillance and control of ports, airports, entry and exit points, as well as certification and investigation of compliance with certification procedures, are strengthened.

I.E. THIS MEANS THAT ALL NATIONAL SOVEREIGNTY IS INCLUDED – MARINE, BORDER, NATIONAL SECURITY, AIR SOVEREIGNTY, NATIONAL SOVEREIGNTY, POLITICAL SOVEREIGNTY.

ANY ACTIONS AND REACTIONS BY GOVERNMENTS, national services, national police, military of the respective country are EXCLUDED. I.E. ANY OTHER NATIONAL BODIES AND ORGANIZATIONS CAN BE USED by the Director-General of WHO including NATO troops.

Each State shall develop, strengthen and maintain, no later than five years after the entry into force of these Regulations, which are MANDATORY FOR EACH STATE, basic capabilities for detection, assessment, notification and reporting to WHO

WHO shall collect and assess this information, without being concerned with the assessment of the STATE CONCERNED.

INDIVIDUAL STATES SHALL PROVIDE THIS INFORMATION every 24 hours after notification to WHO.

Any consultations between the State and WHO shall be IN CAMERA, SECRET.

If the Member State concerned does not accept the offer of cooperation which WHO IMPOSES, WHO may and HAS THE RIGHT to share with other Member States the information it has.

WHO ENCOURAGES AND REALLY FORCES the relevant member state TO ACCEPT THE PROPOSAL FOR PARTNERSHIP of WHO and ITS GOVERNMENT OF THE STATE.

In reality, if a country does not agree with WHO, WHO can FORCE NEIGHBORHOOD STATES TO CLOSED BORDERLINES - AIR, LAND, SEA with the relevant STATE AND IN THIS WAY FORCE IT TO ACCEPT THE INSTRUCTIONS and TO IMPLEMENT THE ORDERS from WHO.

- Along with the standard measures of disinfection, deratization and disinfestation from a "given country" may also require information about the full itinerary of passengers, luggage or shipments, as well as a non-invasive medical examination of a "suspicious passenger".

The Regulation is MANDATORY.

Point 14. Passengers who must be vaccinated or offered preventive treatment in accordance with these Regulations, or their parents or legal guardians, must be informed of any risk associated with vaccination or the use of preventive treatment and of the risk of disease and of not being vaccinated or using preventive treatment.

I.e. EVERY PASSENGER IS OBLIGATED TO SUBMIT THE MEASURES MENTIONED IN point 14 – vaccination and others. THIS IS A FORCED DICTATION

This applies to EVERY PASSENGER, even if he is not a patient.

EVERY PASSENGER WILL NOT REALLY HAVE ANY RIGHTS TO CHOOSE.

EVERY TRAVELER FAR FROM HOMELAND IS ACTUALLY FORCED TO BE VACCINATED IN ORDER TO BE ABLE TO RETURN HOME.

I.E. THERE ARE NO AND CANNOT BE ANY DISOBEYING TRAVELERS HERE,

I.E. WHO ASSUMES THE OBLIGATION TO IGNORE THE RELEVANT STATE AND TO IMPOSE MEASURES AND ACTIONS ON THE TRAVELERS WHATEVER IT DESIRES.

MEASURES FOR TRANSPORTATION ARE EVEN SEVERE.

EVERY TRAVELER TRAVELING WITH RELEVANT CLOSE ONES, and in fact his CLOSE ONES ARE COVERED BY THE ACTIONS AND MEASURES OF WHO.

MASTERING NATIONAL SOVEREIGNTY and all types of SOVEREIGNTY

Art. 42 determines that the measures applied by the states must be in accordance with the national legislation.

AT THE SAME TIME Art. 43 requires THAT NATIONAL LEGISLATION MUST BE IN ACCORDANCE WITH INTERNATIONAL NORMS and that related to public health.

I.e. NATIONAL LEGISLATION IS IGNORED IN PREFERENCE TO THE REGULATIONS OF THE INTERNATIONAL ACTS of a SUPRANATIONAL ORGANIZATION LIKE WHO.

AT THE SAME TIME THE SOVEREIGNTY of personal DATA, personal information, is also being taken away.

According to point 2 of art. 42, it is permissible in theory, but not in practice, for a country to apply only its own

national measures, but if it dares to behave in such a way, point 6 gives it a period of 3 months to reconsider its actions and finally comply with the criteria and recommendations of the WHO.

Although personal and health data according to art. 45, which identifies a person, were confidential, **THEY CAN BE PROCESSED and DISCLOSED** when necessary at the request of the WHO.

- The cooperation provides for reporting to the WHO on the measures taken by the countries.
- According to Art. 45, personal and health data relating to an identified or identifiable person were confidential, but...regardless of this, they could be processed and disclosed when necessary for the purposes of assessing and managing public health risks, and of course - at the request of the WHO.
- Who draws up a list of experts for the IHR? Who appoints one member from each country to intergovernmental and regional integration organizations? Who creates the Emergency Committee? Who appoints the consultants to the Emergency Committee? Only one answer - the Director-General of the WHO. You see how, by sending their proposal for membership in these bodies, the countries themselves put their officials in the WHO as intermediaries of the dictatorship. And then they declare to us that they did not carry out the will of the WHO. Yes, they are right because they left the will at the disposal of the official sent to the WHO, whose job is to comply with its statute and policy. He stops working for the country whose representative he is. Therefore, it is unnecessary to ask who our delegates to the WHO are. Whoever they are - **THEY ARE NO LONGER OURS**.
- The first report on the results of the new IHR will be submitted to the WHO General Assembly after the 1st and before the 5th year from the entry into force of the new IHR.
- There is also a Committee for the Implementation and Compliance of the International Health Regulations, which will "encourage" (i.e. put pressure on) their implementation and monitor the compliance of other international regulations with these rules (i.e. a legal and administrative laboratory for the correction of non-compliant legislation). Let's see the response of our representatives, who are beating their chests that they will introduce laws to improve the standard of living and our economy, when they have to vote on changes and revisions to national legislation and international treaties, and even concessions that do not comply with the IHR. Article 57 gives states the right to interpret all other international regulations and agreements as they wish, as long as they do not contradict the IHL (i.e. the highest law may not be either the Constitution or national or international legislation, but the WHO rules). It is not even a question of implementing

laws, but of interpreting them. We may have very good laws, but if they contradict the IHL, they will have to go to mandatory interpretation. We have already seen how the constitution and laws are interpreted when they contradict European regulations, so when deputies swear to abide by them - we must interpret their oath in accordance with the interpretation in conditions of contradiction of the noems.

It is envisaged that disputes between individual states under the new IHL will be referred to the Director-General of the WHO or to the permanent International Court of Arbitration, and disputes between the WHO and individual states to the World Health Assembly.

VACCINATION CERTIFICATES

Article 36 gives a green light to holders of vaccination certificates, even if they show signs of the disease, but also gives the competent authority to which the certificate is presented the right to refuse the traveler to continue if that control authority has access to verifiable indications and evidence that the vaccination was ineffective. If the WHO authority shows, but does not prove, that the vaccination **WAS INEFFICIENT**, it can impose vaccination actions.

The criterion of "effectiveness" is not commented on deliberately

Through **FULL CONTROL and MANAGEMENT** of the certification of carriers, control is given to trade and the entire economic process between countries, who **CAN TRADE, WHY, and WHO CANNOT**.

Each carrier will be required to fill out "health declarations" and certificates of sanitary condition of vehicles valid for 6 months.

According to Art. 40, point 2, passengers may be charged health fees

Every person can be treated or quarantined for a fee or vaccinated for free.

It is possible to **QUARANTINE** a person.

Under the pretext of a "false positive" a person **CAN BE FORCEDLY QUARANTINED** - i.e. **THE UNCOMFORTABLE PERSON**.

- 6) International Sanitary Convention of 1944, amending the International Sanitary Convention of 21 June 1926, opened for signature at Washington on 15 December 1944;
- 7) International Sanitary Convention relating to Air Navigation of 1944, amending the International Sanitary Convention of 12 April 1933, opened for signature at Washington on 15 December 1944;
- 8) Protocol of 23 April 1946 extending the International Sanitary Convention of 1944, signed at Washington;
- 9) Protocol of 23 April 1946 extending the International Sanitary Convention of 1944, signed at Washington;
- 10) International Sanitary Regulations of 1951 and the Supplementary Regulations of 1955, 1956, 1960, 1963 and 1965; and
- 11) the International Health Regulations of 1969 and their amendments of 1973 and 1981.

ENTRY INTO FORCE, REJECTIONS AND RESERVATIONS Art.59 and Art.61

The Amendments are scheduled to enter into force on 31 May 2024.

This must be done at the table of the World Health Assembly of the World Health Organization from 27.05.2024 to 01.06.2024.

Within 18 months of the entry into force of the International Health Regulations, States may reject the Regulations or make reservations. After this period, nothing will be possible.

If a country is not able to fully adjust its domestic legislative and administrative regulations with the IHR within 18 months, it must do so within an additional 12 months after the first 18 and if it has notified the Director-General that it wants an additional period.

So, between 27.05 and 01.06.24, the development of progress in the agreements on these amendments to the existing International Health Regulations from 2005 will be reported.

Formally, their difference with the pandemic instrument is that they may not be legally binding, but for this purpose, political will and representation in the WHO structures that is truly committed to our rights are required, which should be opposed within the given time limits.

And it is best not to have any participation in this specialized UN agency at all.
