- In this short and massive process of manipulation, people do not have time to doubt the messages, the data, the facts.
- In reality, manipulation hides aggressive intentions and behavior.

- In reality, manipulators know the psychological vulnerabilities of people.
- Manipulators do not worry at all about the damage, moral, emotional, psychological, behavioral and others to people.
- In reality, there is deception by default.
- Manipulators do not give any direct answers, scientifically substantiated, manipulation and manipulation occurs through threats.
- They increase fear and uncertainty.
- The goal is unconditional obedience.
- The goal is obedience, and the implementation of any actions and measures
- The resistance of people's consciousness to think, discuss, evaluate data, facts, evidence is actually eliminated.
- The goal is confusion, through accusations.
- Manipulation uses anger, fear, threats.
- Manipulation excludes independence, the ability to oppose. Through threats, fear is generated, threats are aimed at naivety, one hundred percent execution of actions, real crushing of consciousness, deprivation of the right to beliefs, to reflection, to meaning, to thought.
- Manipulation makes people emotionally dependent one hundred percent on manipulations through media, information networks and systems.
- Through manipulation, trust is forced.
- Through manipulation, the goal is and is achieved blocking the mind, blocking the thought, blocking the ability to think, to reason, to conclude statements, blocking the possibility of analyzing data, facts, results, analyzing lies, assessing the truth, distinguishing lies from the truth.
- There is no truth here, or lies, only what is claimed is the forced truth.
- There is and is a real substitution of facts and evidence.
- Personal beliefs are attacked and manipulated and erased and destroyed - political, religious, moral, worldview, habits, style of behavior, ways of thinking, habits, mental and emotional suppression and coercion.

- The right to terminate a prosecution on the pretext that it is a state secret
- The extradition of detainees to other countries, including those in which it is assumed that the extradited will be subjected to torture
- The murder of American citizens by order of the President.
- Unconstitutional exercise of power over citizens
- The FBI conducts electronic spying in violation of the Fourth Amendment to the Constitution.

The assassination serves as a justification for wars, the conquest of countries, wiretapping, kidnapping, and calls into question the civil and constitutional rights of citizens in a democratic society.

The beginning of the preparation of this fight against terrorism began in the 80s of the 20th century, when the West and the USA supported, created Islamic integrism, with the ultimate goal of opposing it to the occupation of Afghanistan by the USSR and to

The war in Afghanistan is called the "war between cultures", or the "crusade" against the Islamized world by the organizers of the fight against terrorism.

- The operation is called Operation Triple Freedom. It begins with 28300 American servicemen.

The money was actually spent without control, one billion was given for helicopters and planes to arm the Afghan state, which have not been used for a long time, one billion was given for the construction of buildings and infrastructure, 34 million US dollars for the cultivation of soybeans, which can

- In addition, soldiers who fought in Iraq and Afghanistan have filed additional claims for \$32.6 billion for disability and medical care.
- Veterans' compensation costs will increase from \$598 billion to \$934 billion.
- The costs range from \$2.9 trillion to \$3.6 trillion.
- George Bush Congress allocates an additional \$120 billion
- The war with IRAQ began on March 20, 2003 when the United States and Great Britain attacked by air, land and sea. Supported by Australia, Denmark, Poland and Iceland.
- Without a declaration from the UN Security Council that legitimized the invasion.

IN REALITY THE PROFITS FROM THIS WAR CREATED THE 2008 FINANCIAL CRISIS according to the THEORY OF CREATION / CAUSATION / GENERATION OF CRISIS by Prof. Momchil Dobrev – 2003.

The Creation of al – Qaeda by The CIA and The USA and The Subsequent War With al Qaeda - Creation of Terrorist Organizations, Their Financing, Training by The USA And The Subsequent Declaration of War Against Them – Against Their Students

- Al Qaeda was created in 1988 and consists mostly of mujahideen who fight against the Soviet invasion, veterans of the war against the Soviet Union 1979-1989. In reality, Bin Laden is financed for this activity by the USA – CIA, according to unofficial data, the CIA has allocated about 500 million US dollars annually for training and military assistance to the mujahideen.
- Later, an Islamic Salvation Fund was created, supported by the United States, the purpose of which was to strengthen Sunni extremism and on an anti-Soviet basis. The goal was to oppose Shiite Iran, which is the main enemy of the United States.
- The goals of Al-Qaeda and the United States are the same - the expulsion of the USSR from Afghanistan.
- After the end of the war, Bin Laden redirected his actions against infidels in all sorts of other countries.
- 1998 Bin Laden created the Islamic International Front to Fight Jews and Crusaders in Afghanistan, after which he was deprived of citizenship in Sudan.

- The headquarters of the organization since 1991, when it was created, were located in Afghanistan and Pakistan. From 1991 to 1996, the headquarters was in Sudan in Khartoum.
- After the fall of 2003, Al-Qaeda moved from Afghanistan to Iraq and Iran.
- The organization is financed mostly by companies under the control of Bin Laden in 35 countries. The fortune of Bin Laden himself is estimated at about 300 million US dollars. The largest economic structures are the companies "Wadi aw Akiz", "Laden International" with a total capital of 300 million US dollars, "Taba Investment", "Hijra Construction", "Al Shamal Islamic Bank".

The creation and financing of the Islamic State by the USA and its partners and the war with them - a process of creating terrorism, financing it, training it, and subsequently declaring war on it.

The brainchild of the group is Samir Abdel Muhammad al-Khalifawi /Haji Bakr/ - a former colonel in the intelligence of Saddam Hussein's air defense forces. He created one of the predecessors of ISIS - the Islamic State in Iraq. He appointed Abu Bakr al-Baghdadi as the leader of ISIS in 2010. He made plans to expand the group into Syria.

He was killed by Syrian rebels in 2014.

He drew up the organization plan, organizational charts, lists, programs, structure and action directives, and the operational program. Haji Bakr drew up the structure of the Islamic State at the local level, ways and procedures for penetrating villages, methods of surveillance, an offensive plan, a technical plan for intelligence management of the Islamic State, a plan for investigating the respected people in the area, their sources of income, a list of the names of the members of the brigades, the names of the leaders of these brigades, an investigation into their illegal actions for the purpose of blackmail and pressure, and extortion in order to carry out the state's orders.

The creative scheme of informants, former intelligence officers, dissatisfied with the system, The plans include schools, kindergartens, media, transport, finances, monitoring systems at all levels, which would guarantee monitoring of everyone and at all levels.

In 2010, employees of Saddam Hussein's Iraqi intelligence services appointed Abu Bakr al-Baghdadi as emir, later as caliph.

The Islamic State is governed by a single leader and four councils - Sharia, religious council, shura - advisory council, military council and security council.

The Islamic State opens missionary offices, through which the organization expands secretly, quietly and very comprehensively. The expansion takes place without resistance, without paying attention and in parallel kidnappings and killings of enemies of the state are carried out. Military camps have been established in many places since the end of 2012, newcomers are trained for two months. The organization is imperceptible and is expanding at a tremendous pace. In the fall of 2013, ISIS had 2,650 foreign fighters. The organization simulates large numbers, with its fighters appearing in black masks and when they appear in many places, large numbers are simulated. Individuals who could be potential leaders or opponents are eliminated.

The main features of ISIS are:

- An insurgent-type organization
- An uncompromising jihadist-Salafist organization
- Extreme terrorist methods and insurgent strategy are used
- Claims to be the true guardian of Wahhabi traditions
- Goal restoration of the caliphate of true Islam in Syria, Iraq and the nearby border territories.

ISIS's budget is \$2 billion for 2015. They sell oil, smuggle goods, trade in people and human organs, donations from the Arab world, their own charity programs, control oil deposits, control oil production facilities, illegal trade in cigarettes, medicines, mobile phones, sell antique artifacts - stolen from Syria and Iraq, kidnappings for ransom, kidnappings for human organs, donations from Gulf countries Saudi Arabia, Kuwait, UAE, Qatar,

systematic racketeering, taxes, racketeering to construction companies, large and small companies.

Propaganda is organized on the social network system and uses all the advantages of these networks, publishing magazines, articles, interviews, , photos, , analyzes - political, military economic analyzes.
