Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva opened in 2008 the law of energy-information gene adaptation, based on a study of the shapes, sizes, and characteristics of young people in development who have been adopted. The conclusion is that children and their characteristics depend on and are formed as a result of the energy-information fields of the persons, the parents, with whom the children live and in whose presence the children develop and grow. Despite such threats, Momchil Dobrev did not surrender his professors Karl Heinz Goethe and Manfred von Ardenne – one of the creators of the nuclear bomb for the Soviet Union – who in 1985, after conversations with Momchil Dobrev, declared him the next Nobel laureate and the genius of the 20th and 21st centuries.

It is no coincidence that at an international conference in 1987, Professor Michael Roth declared Momchil Dobrev, presenting him to over 500 professors from the whole world, the genius of the 20th and 21st centuries.

At that time, Momchil Dobrev studied theoretical physics, biology, neurophysiology, medicine, logic, cognitive psychology, chemistry, various medical sciences, brain sciences, and other sciences.

These are not accidental things. As a first-grade student, Momchil Dobrev solved math problems for the 3rd–4th grade. As a third-grade student, he solved problems from the 6th–7th grade on tests in just 10–15 minutes, without anyone dealing with him and without even his family providing appropriate training.

integral part of the 16-dimensional field of the universe (2003), and the experiments of Lord Prof. Momchil Dobrev from 1985 and from 1991–2003 with the levels of consciousness, the raising of the eighth level of consciousness, and the opening of a portal for travel of consciousness in the universe at instantaneous speed, much greater than the speed of light. This represents a real denial of Einstein and dialectical materialism, and provides an explanation of dark energy and dark matter.

The ether – field structure

The ether is a field structure with a precisely defined geometry that contains consciousness at the zero point.

Theory of the universe

The theory of the universe by Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva (2005) represents a general description of life in space and the universe, encompassing physics, biology, chemistry, genetics, psychology, psychiatry, and other sciences.

The theory of the universe by Prof. Momchil Dobrev and Mariola Garibova-Dobreva is based on the model and equations developed by Momchil Dobrev between 1985 and 1991, from which follow the basic postulates and the theory of species and levels of consciousness in the universe (1991) by Lord Prof. Momchil Dobrev.

The universe consists of a multidimensional structure composed of 16 levels of dimension, which include parallel universes, the essence of which is not discussed here.

Each dimension represents a frequency sphere of density, a matrix upon which the dimension is based and rests on a precisely defined frequency sphere.

Each higher level of dimension is supported by a precisely defined frequency sphere that is harmonic and several degrees higher than the previous dimension.

Every advancement of matter and field matter of any being in a given dimension is invisible to the previous dimension and becomes invisible when it is encompassed, as it resonates on that frequency sphere.

The transition from one dimension to the next occurs after a precisely defined rotation in a precisely defined direction, consisting of a 90-degree rotation and a rise to the next harmonic level of the frequency sphere of the previous dimension.

Each dimension has a consciousness that resonates on the corresponding harmonic levels, spectra, and frequency sphere.

Human consciousness can rise from one level-dimension to another after interference of the sound spectra and the

corresponding frequency sphere of the respective dimension.

Consciousness moves at a speed much greater than the speed of light. Consciousness moves instantaneously.

Consciousness can receive information and see every object in depth and structure. Consciousness also possesses corresponding tentative organs.

These conclusions are proven by experiments conducted by Lord Prof. Momchil Dobrev since 1985 in Germany, and later from 1991 to 2003, using precisely defined techniques and procedures refined and created by Lord Prof. Momchil Dobrev.

All of this is supported by the ether and its field structure, which has a geometric form.

For this purpose, in 1991 Lord Prof. Momchil Dobrev created a new metrics and a new topology based on the principles of nature: the golden ratio, the Fibonacci series, fractal structure, and holographic inclusion of information.

At the base of the fractal structure lies the structure of the Fibonacci spiral and the logarithmic curve. The basic principle and reason for twinning in the universe is that the Fibonacci series, corresponding to the spiral, moves with acceleration. They are generated from the motion of the core of the respective sun, which causes the corresponding vortex. From these experiments arise three equations and forces that hold each planet on its respective orbit depending on the energy-electronic informational potentials.

Unlike the equations of Kepler and Newton, which are descriptive and do not provide the original cause of planetary motion, the equations of Lord Prof. Momchil Dobrev describe and provide this solution.

This is based on vortex fields and vortices caused by the zero-point field of unlimited energy-informational conscious potential.

Every object in the universe possesses consciousness at its respective level.

Ether is a field structure that contains all 13 levels of consciousness and penetrates the innermost levels of all

matter. 2.2. Theory of the structure of consciousness

In 1991 and 2003, Lord Prof. Momchil Dobrev created a theory of the structure of consciousness as an energy-information system in the universe that forms matter.

Based on experiments conducted systematically since 1985 in Germany, then from 1991 in Bulgaria until 2003, Lord Prof. Momchil Dobrev developed his theory of the structure and levels of consciousness as part of the universe.

This structure consists of 13 levels, with only 12 levels accessible to human souls.

As the dimensions of the universe field are 16, each dimension possesses consciousness. This is an information structure that operates on matrix, fractal, and holographic principles.

The movement along the path of consciousness from the third level of consciousness, which is the human level, toward the higher levels up to 16 does not occur in the same manner for all levels.

Each level of consciousness exists within a specific sound harmonic coherent matrix and has precisely defined frequency harmonic characteristics that are harmonious with the lower level.

The structure of the consciousness field consists of levels of consciousness, a basic channel through which transitions from one level to another occur, and rules governing these transitions.

Each level of consciousness has its own sound matrix that defines it.

In the presence of a sound complex that encompasses the sound matrix characteristics of multiple levels of consciousness and harmonically integrates them, consciousness can move from one level to another.

If the harmonic sound matrices of two or three levels are present, the consciousness of an individual can pass through these levels and stop at the last level whose sound matrix corresponds to the final state.

Each level of consciousness also has corresponding sensory organs.

According to the law, through human thought, consciousness is governed in its movement through the universe.

Through experiments conducted from 1985 in Germany until 2003, the consciousness of Lord Prof. Momchil Dobrev rose to the eighth level of consciousness and was governed through thought within the universe.

If the movement is directed toward the universe, consciousness begins to move in the direction determined by thought.

Experimental procedure for opening a portal of consciousness

An experimental procedure exists for opening a portal of consciousness through which consciousness can perceive every object in the universe, from the smallest to the largest scale.

Initially, with eyes closed, the person imagines a ball of fire above the head. Through thought, this ball is moved from the crown to the first chakra and back. At a certain point, the movement is accelerated through thought from the seventh to the first chakra and back. This refers to the main seven chakras of the human body, although there are many more.

Depending on polarity, which differs between men and women, solar discs are mentally created at the level of the seven main chakras and rotated in a specific direction through the power of thought.

Depending on polarity, discs 1, 3, 5, and 7 rotate to the left, while discs 2, 4, and 6 rotate to the right, or vice versa.

When listening to a precisely defined sequence of sounds that corresponds to and covers all frequency sound characteristics and matrices of each level of consciousness through the channel of consciousness, the eighth level of consciousness is reached without difficulty after the procedure involving the light ball and the rotation of the corresponding solar discs. This movement accelerates the process of coherence and synchronization.

3). Experimental continuation

At the next moment, a beam of light is released from the first to the seventh chakra, or from the ball of light described in step 1. This beam moves from the first to the seventh chakra and, upon reaching the seventh chakra, is directed by the power of thought at a 45-degree angle toward the visual screen. This is the visual field of consciousness.

Since the visual field of consciousness is positioned at 45 degrees relative to thought, the golden ball is also tilted at a 45-degree angle to the horizontal plane between the eyes. At this 45-degree angle lies the visual screen of the person and the visual screen of the consciousness.

Throughout this process, music containing the harmonic frequencies of the third, fourth, and fifth dimensions flows around the person with closed eyes. moment when the golden sphere emits the corresponding energy and frequency, the desired object appears before the “eyes” of consciousness.

Conclusions according to the theory of the structure of consciousness

According to the theory of the structure of consciousness, the following conclusions follow.

Materialization of thought forms occurs between the sixth and eighth levels of consciousness.

Healers such as Sai Baba and others had access to the sixth level of consciousness, where, through thought alone concerning the illness of a person before them, a powdered substance materialized in the hand. This substance was given to the sick person, after which healing occurred.

The eighth level of consciousness is located harmonically within the corresponding harmonic matrices of the energy chakras, which are harmonious with the main seven chakras in the third dimension of the human being.

Thought can direct consciousness not only toward the structure of a galaxy or a star, but also toward the microworld. Through thought, consciousness transits instantly to wherever it is directed. This is possible due to the fractal structure of the universe and the capability of consciousness to move instantaneously within the corresponding structure, whether microstructure, megastructure, or other.

Experiments of Lord Prof. Momchil Dobrev

Using these rules, Lord Prof. Momchil Dobrev opened the correct channel or portal, which any person can open in order to access the universe and see whatever they wish, even if it is billions of light years away.

The model of consciousness includes levels, degrees, types, topology, and metrics. In 1991, Lord Prof. Momchil Dobrev conducted a series of experiments related to this model.

Throughout the entire process, music is present that combines harmonic frequency spectra of the third, fourth, and fifth dimensions.

Postulates derived from these experiments

Consciousness moves at a speed much greater than the speed of light, instantaneously, because consciousness has a fractal-holographic structure with fundamental characteristics based on the Fibonacci series and the golden section. Rejection of dialectical materialism

These experiments truly reject dialectical materialism and the statements based upon it. More than 20 years ago, Lord Prof. Momchil Dobrev rejected the basic laws of Hegelian dialectics.

Dialectical materialism is a scientific philosophical worldview and a component of Marxism. Its subject is the most general laws of development of nature, society, and thinking, as well as the general principles and foundations of the objective world and its reflection in human consciousness.

The main constants of dialectical materialism state that the human being is material and objective, that consciousness is a subjective reflection of objective reality, that being determines consciousness, that human existence is social, that the meaning of existence lies in historical material consequences, that society is divided into classes, that historical development is driven by class struggle, and that the struggle concerns the ownership of the means of production.

Through the experiments of Lord Prof. Momchil Dobrev with consciousness, it is proven that consciousness moves matter and is primary, while matter is secondary. Consciousness is primary, and all other movement is secondary.

Dialectical materialism, according to this view, is used by a corporate oligarchy to manage and control social, economic, philosophical, and scientific processes and to suppress scientific progress.

More than 20 years ago, Lord Prof. Momchil Dobrev rejected Hegel's idealistic dialectics, publishing this rejection in dozens of articles.

Matter and consciousness

Dialectical materialism is based on the primacy of matter and the derivation of consciousness from being. Matter is considered absolute, indestructible, eternal, and infinite, while movement, space, and time are viewed as its fundamental forms of existence.

The experiments of Lord Prof. Momchil Dobrev with consciousness, and the theory of types and levels of consciousness developed by him as part of the theory of the universe and the structure of the universe, prove that consciousness determines being, that it is primary and leading.

Consciousness is what creates matter.

The law of the transition of quantitative accumulations into qualitative changes is one of the basic laws of

dialectics and explains how and in what way movement and development occur. This law was formulated by Georg Wilhelm Friedrich Hegel and was subsequently recognized by the theorists of Marxism.

The law of negation of negation is one of the basic laws of dialectics. Lord Prof. Momchil Dobrev proves the invalidity, illogicality, causelessness, and inconsequential nature of this law.

The hidden ideology of financial-banking materialism and the critique of Hegel and Marx

According to Lord Prof. Dr. Momchil Dobrev, the real historical process since the eighteenth century has not been driven by the historical materialism of Karl Marx, but by a financial-banking, resource-technological, mafia-informed materialism operating internationally.

Lord Prof. Momchil Dobrev presents a critical analysis of Hegel and Karl Marx. In reality, since the eighteenth century, financial-banking resource-technological materialism has operated globally, rather than the historical materialism proposed by Marx.

Thesis number one: In the beginning there was matter

This thesis formulates the principle of the supremacy of matter without evidence and leads to consciously incorrect conclusions. In reality, based on the theories developed by Lord Prof. Momchil Dobrev—cosmological theory of information, theory of vortex fields, theory and practice of free energy, theory of information-energy medicine, theory of the universe, energy-information genetics, energy-information psychology, and energy-information psychiatry—spirit, consciousness, and thought are primary, and matter follows.

Thesis number two: Being determines consciousness

According to this thesis, economic conditions, or being, determine the thinking and personality of an individual, namely consciousness. According to the theories of Lord Prof. Momchil Dobrev, spirit, consciousness, and thought determine being, and not the opposite.

As early as 1933, Sigmund Freud criticized both Hegel and Marx. The observable fact that different people, races, and nations behave differently under the same economic conditions excludes the absolute determining power of economic factors.

Based on this theory, Marx developed historical materialism, asserting that only the economy and ownership of the means of production are decisive.

Historical materialism claims that goods, products, and property determine the course of history by forming social classes.

The financial-banking resource-technological materialism developed by Lord Prof. Momchil Dobrev, following a complete analysis of the history of finance and global economies since the thirteenth century, concludes that bankers and financiers, through the creation of conflicts and wars, shape history. According to this view, the materialism identified by Lord Prof. Momchil Dobrev-Halachev represents reality, while Marx's historical materialism represents manipulation.

Thesis number three: History is the history of class struggles

Marx maintained that all human history could be reduced to class struggles. He viewed history exclusively as a history of class struggle, except for prehistory, and distinguished between successive stages of development.

According to Lord Prof. Momchil Dobrev, however, since the eighteenth century it has been financial-banking resource-technological materialism, rather than Marxist historical materialism, that has operated internationally.

Thesis number four: Class struggle leads to the dictatorship of the proletariat

This thesis claims that class struggle necessarily leads to the dictatorship of the proletariat and the eventual disappearance of all classes.

The law of energy-information gene adaptation

Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva developed the law of energy-information gene adaptation as a subject of practical research. This study proves energy-information gene adaptation and is presented as evidence that consciousness, as an energy-information system, forms and creates matter with consciousness or commands the creation of matter through consciousness.

This represents a new view and proof in physics, biology, and cosmology and is presented as rejecting Darwin's theory and dialectical materialism.

The law of energy-information gene adaptation, developed by Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva, is described as one of the key evidences for rejecting Darwin's evolutionary theory and dialectical materialism.

Study on consciousness and energy-information gene adaptation

This study demonstrates the influence of the environment, and more specifically the influence of the energy system of a person or group of people, on the energy system of a child or young person in the process

of growth and development between the ages of three and eighteen.

From the practice of Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva, it is shown that a person's own thoughts, the thoughts of others, influences from previous lives, influences from the present life, influences from other people, and energetic impacts affect development.

Their practice indicates that when a child is in the phase of development, the energy-information field of the parent with whom the child lives forms, influences, and causes energy-information adaptation. This adaptation is reflected in physical forms such as height, size, thickness, and body structure.

The energy-information field of the parent with whom the child lives plays a determining role in shaping the child's physical body. The energy-information field of the parent, including feelings of love, care, attention, and respect, influences the size and shape of the child's physical body.

The energy-information field of the parent, including feelings, thoughts, verbal and nonverbal communication, affects the shape and degree of development of the child's physical body.

Depending on which parent is dominant in the family, the formation of the child's physical body is influenced accordingly. When the energy-information system of the father is dominant, it affects the physical form of the child, who follows the size and physical structure of that parent.

The law demonstrates that the energy-information field of the parent influences the material structure and the energy-information field of the child, shaping the child's physical form, size, and dimensions. First, the energy-information field of the parent forms the energy-information field of the child, which then forms the physical, material body.

This proves that the energy-information field forms matter. This is described as the law of formation of matter from the energy-information field of the dominant parent.

Empirical study

Thirty-three families with adopted children were studied. One third consisted of families in which both parents raised the adopted child up to the age of twenty. One third consisted of families in which one parent had died or separated, with the child remaining with the mother after the age of seven to thirteen.

The results proving energy-information adaptation are as follows. Adopted children grow and acquire primary features such as body structure, muscle structure,

thickness, bone structure of the legs and arms, muscular development, and facial characteristics, becoming physical copies of their adoptive parents. This also applies to height.

After studying the biological parents of the adopted children, including their height, muscular structure, volume, thickness, and other physical characteristics, it was found that the adopted children showed no correspondence with their genetic parents. Height, size, body structure, thickness, bone structure, and muscle structure did not correlate with the biological parents.

Adopted children fully acquired the characteristics of their adoptive parents, most strongly reflecting the dominant parent. If the child was raised by only one parent, the child adopted the characteristics of that parent, whether mother or father.

Even the presence of a tummy in the adoptive parent, especially the mother, determines the presence of a tummy in the adopted child. This is observed in all thirty-three surveyed families. Due to the enormous database and the complete coincidence of the traits of the adopted children with those of the adoptive parents, it is not possible to present all empirical materials. Therefore, only the conclusions are presented.

That is, there is indisputable evidence of induced and forced energy-information gene adaptive modification in adopted children with respect to their adoptive parents—those who adopted and raised them from an early age, between three and eighteen years of age.

DNA is read differently depending on the folding of the gene, its twisting or non-twisting, and the energy-information field created around the gene itself. The twisting or non-twisting of DNA occurs as a result of the energy-information field surrounding the person and the body. The state of DNA depends on the overall energy-information field around the individual.

The influence of the energy-information field surrounding a young person—which includes emotions, thoughts, feelings, words, sounds, and other informational components—is greatest when the young person is in the process of growth and development.

Adopted children fully acquire the characteristics of their adoptive parents in every respect, most strongly reflecting the dominant parent. If the child grows up with only one parent, the child acquires the physical characteristics of that parent, whether mother or father.

Even the presence of a tummy in the adoptive parent—especially the mother—determines the presence of a tummy in the adopted child. This is confirmed in all thirty-three families studied. Due to the volume of material, only the conclusions are presented.

Thus, there is undisputed evidence of compulsory energy-information gene adaptive modification of adopted children relative to the adoptive parents who raised them between the ages of three and eighteen.

The energy-information field of adopted children is directly and immediately influenced by the energy-information field of the parent or parents with whom the child lives most of the time in the same dwelling. As a result, these young people grow and acquire primary characteristics—body structure, muscular structure, volume, thickness, bone structure, body proportions, abdomen formation or lack thereof—becoming physical copies of those who raise them.

This also applies to height and the dimensions of body parts such as arms, legs, torso, shoulders, and overall physique.

The referenced sketches demonstrate these conclusions: the solid line represents the shapes of the adoptive parent and the adopted child, while the dashed line represents the dimensions and shape of the biological parents.

Conclusions

The conclusions are that consciousness, which is the informational energy matrix of the human parent, influences the consciousness of the adopted child.

There is a transfer of consciousness and information from one person to another, which controls the gene expression of the child and translates informational content from the parent to the child.

Consciousness is the basic structure of the universe. Consciousness, as an informational energy system, creates matter and is the cause of the creation of conscious matter.

Prince Lord Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva

This law represents a real denial of Darwin's theory.

Darwin's theory of evolution

Darwin's theory of evolution is a scientific theory explaining the development of life on Earth. According to this theory, the diversity of species results from gradual processes occurring over long periods of time, during which organisms evolve from simpler to more complex forms, adapting to their environment.

In *The Descent of Man* (1871), Darwin argued that humans belong to the animal kingdom, traced physical and psychological continuity with animals, and introduced sexual selection. He emphasized that all humans belong to one species.

In *The Expression of Emotions in Man and Animals*, Darwin explored the evolution of human psychology.

Darwin concluded that despite humanity's intellectual and moral capacities, humans still bear the biological imprint of their lower origin.

Law of consciousness-informational energy gene adaptation as evidence against Darwinism and dialectical materialism

The discovery made in 2008 by Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva provides evidence that the energy and information influence from adoptive parents on a young child causes real changes in physical and mental qualities, skeletal structure, body structure, and behavior.

These changes occur during continuous contact between adoptive parents and the adopted child from early childhood until eighteen years of age. The shaping of the child's body, height, dimensions, and physique is transferred through energy-information exchange from parent to child.

The regulation of gene activity depends on the environment in which the human energy system exists, including the living environment, the people with whom the person lives, and the combined influence of surrounding energy systems.

A gene is a fragment of the hereditary DNA molecule containing the construction code of specific body components. Each gene also contains regulatory sequences, known as gene triggers. Gene regulation determines whether and in what quantity a corresponding protein is produced.

Experiences and lessons. Gene reading and the role of the energy-information field

The membrane determines how a gene will be read. The membrane is influenced by both the field and the information contained in the field of the environment, including the energy-information fields of other people with whom the developing organism lives.

Each field contains corresponding information about itself. In addition, the energy field surrounding the cell—the fractal energy-information field with its corresponding level of consciousness—determines how the gene will be read.

The external environment does not merely suppress the gene; it readjusts it in such a way that this adjustment remains stable throughout the individual's lifetime. The energy-information field and the environment surrounding the child during growth and development determine the parameters of change to which the child's energy-information field is subjected. These parameters define the adaptive modification of the child's genome.

The energy field contains information. In reality, the higher-dimensional aspect of the energy field represents the consciousness of the respective cell. Regulation

Gene regulation is not determined by the gene itself. Regulation is carried out through specific regulatory "lists" for each gene and occurs as a result of the energy-information field of the environment in which the child lives, including the parents, relatives, and social surroundings.

Regulatory sequences and consciousness

Whether transcription factors bind to regulatory triggers and how genes are activated depends on the energy field surrounding the cell and the body as a whole.

The brain is the organ that generates thoughts, and these thoughts produce corresponding signals. Cells possess consciousness. Consciousness contains all information about the past, functions, self-organization, and life itself.

Consciousness is the information field of the individual, determining character, behavior, thoughts, feelings, and emotions.

Based on the evidence presented, it is proven that the energy field of the parent affects the energy field of the child and, through this influence, models gene regulation in a state of harmony, coherence, and synchronization.

There exists coherence and synchronization at the energy level, the field level, the informational level, and the level of consciousness of the respective energy field.

Every field and every dimension has an informational field that can be described as consciousness. This consciousness represents information about the field itself and its coherence with the universe as a whole.

Thoughts are frequency patterns that represent fields carrying specific information. Thoughts are informational structures that can alter and influence the genome.

Each higher dimension possesses its corresponding consciousness, granting access to all levels, including the current dimension and lower-dimensional levels. Each dimension has its own density and characteristic properties.

Gene expression, proteins, and information flow

Genes produce groups of substances that command physiological processes in the body. Proteins guide essential biochemical processes in cells. As enzymes, they circulate through the bloodstream. As hormones and neurotransmitters, they transmit informational signals between cells and throughout the body.

Proteins are received by receptors located on the outer surface of cells, which are themselves proteins. The

blueprint for producing a protein is encoded in the gene as a DNA sequence.

Protein regulation includes not only the structural plan but also the quantity in which proteins are produced. Genes can be read in different ways.

Reading genes differently depends on the folding of the gene, its twisting or untwisting, and the energy-information field formed around the gene. Information and energy determine the folding of the gene. The shape of the folded gene results from the surrounding energy-information field.

The field structure of the gene provides instructions on how the gene is to be read. This field structure depends on the field structure of the environment and the field structure surrounding the DNA itself.

This explains why the number of functional gene expressions exceeds the number of genes themselves. The manner in which DNA is wound, twisted, and folded determines how it will be read.

Basics of energy-information sciences

The basics of energy-information genetics, energy-information psychology, energy-information psychiatry, energy-information medicine, and energy-information archaeology are based on the theory of the universum developed in 2005 by Prof. Mariola Garibova-Dobreva and Prof. Lord Momchil Dobrev-Halachev. This theory includes the law of energy-information gene adaptation.

The theory of the universum distinguishes the following disciplines:

- Energy-information medicine
- Energy-information genetics
- Energy-information psychology
- Energy-information psychiatry
- Energy-information archaeology
- Energy-information physics

Based on the cosmological information theory and vortex field theory, Mariola Garibova and Momchil Dobrev developed the theory of the universum in 2005.

Through research on the human energy system and its influence on precisely defined diseases, it has been demonstrated that chakras represent human energy centers formed as double vortices capable of rotating in both directions. The interdependence between human energy and the environment operates at both conscious and subconscious levels.

Connections have been established between human conditions, illnesses, and the state of the energy system, including chakras, energy flows, consciousness, and subconscious processes. Diseases examined within this framework receive clear explanations and holistic therapeutic approaches that integrate physical and energetic dimensions.

From these studies emerged new interdisciplinary fields, including energy-information genetics, energy-information psychology, and energy-information psychiatry.

Due to the vast scope of the subject, which would require a monograph of 1,500–2,000 pages, only summarized results are presented here.

Consciousness and information

Information is the primordial essence that gives rise to all existence and all life. Information is a component of consciousness, which is a living system that stores, receives, renews, transmits, and governs the processes of life.

Consciousness, through information, influences the energy field and, through it, matter.

Consciousness operates through information based on signals from:

- Food
- Nature, plants, and animals
- The Earth's energy-information field
- The energy-information field of other people
- The energy-information field of the Sun
- The energy-information field of the universe
- The subconscious, including experiences from past and present lives

Consciousness and information are influenced, directed, and governed by energy fields, which in turn affect matter.

An energy-information matrix of consciousness exists in the Earth, the Sun, the universe, and the human being. Consciousness differs across densities and dimensions and represents an informational matrix composed of interacting field structures.

In humans, information fields correspond to twelve dimensions of consciousness based on vortex field types. This structure explains the double-helix and counter-directional nature of DNA. The reading and writing of DNA information occur in one specific direction, associated with the generation of vortex energy.

Ancient representations of serpents symbolize this direction of informational reading and energy generation. The twelve dimensions correspond to the six double strands of DNA, demonstrating the existence of a twelve-dimensional informational structure in human DNA.

Some basic postulates of the theory of the universe by Prince Prof. Momchil Dobrev-Halachev and Prof. Mariola Garibova-Dobreva

Some basic postulates of Prince Prof. Momchil Dobrev-Halachev's and Prof. Mariola Garibova-Dobreva's "Theory of the Universe" and "Theory of energy-information genetics and energy-information medicine and psychology" are presented here. These theories are stated as the basis on which Prof. Momchil Dobrev won the 2021 World Championship in Fundamental Physics, and Prince Prof. Momchil Dobrev together with Princess Prof. Mariola Garibova-Dobreva won the 2022 World Championship in Genetics.

This section describes studies conducted by the team of Prince Prof. Momchil Dobrev and Princess Prof. Mariola Garibova, which claim to prove the nature of depression as a mental disorder based on the theory of the universum developed in 2005 by Prof. Mariola Garibova and Prof. Lord Momchil Dobrev-Halachev, as well as on the cosmological theory of information and vortex field theory developed by Lord Prof. Momchil Dobrev, describing the basic structure of the universe.

In 2006, both Prince Lord Prof. Momchil Dobrev and Princess Lady Prof. Mariola Garibova-Dobreva developed energy-information medicine, energy-information genetics, and energy-information psychology.

Basic postulates following from the theory of the universe, theory of vortex fields, and energy-information medicine and genetics

Postulate number 1

Each organ oscillates within a specific frequency spectrum when it is in a healthy state. This spectrum represents a defined interval, referred to as the healthy interval. When an organ emits frequencies both within this healthy interval and outside it—either above or below—then the organ is considered sick. Every pathogen, bacterium, virus, and similar agent emits and oscillates within a specific frequency spectrum and emits scalar waves.

Postulate number 2

Within the human energy-information system, there exist specific frequencies associated with regeneration. There is a specific frequency that regenerates human DNA and serves as a system for the regeneration of each human organ. There exists a frequency and its harmonic that regenerate both human DNA and every human organ.

Postulate number 3

Each organ has its own specific frequency for the regeneration of its cells.

Postulate number 4

Organ regeneration is carried out through modulation of the basic frequency that regenerates DNA, modulated by the frequency of cellular regeneration. When the

regeneration frequency of the cells of a specific organ is superimposed on the carrier frequency of DNA regeneration, both regeneration and treatment of the organ become possible.

Postulate number 5

Treatment of pathogens and other harmful agents is possible through interference. Since each pathogen emits and oscillates within a specific frequency spectrum, generating the same spectrum with identical parameters and directing it toward the pathogen results in interference that leads to its destruction.

Postulate number 6

The information code is a matrix continuously emitted by every living object, including organs, structures, and the human body. This information code represents a cross-section of the vortex radiation of the respective organ or object.

Postulate number 7

The information code is read in a vortex manner, counterclockwise.

Postulate number 8

Treatment of a specific organ can be performed either through interference using a frequency spectrum corresponding to that organ or through the information code transmitted in the same mirrored way as its reading.

Postulate number 9

The distribution of particles and electrons in circuits and other systems occurs through alternating wave and particle behavior. The wave center is a right-clockwise rotation of all light frequencies. When the values of the electromagnetic field are non-zero, light manifests as a wave, and at the zero point, where electric and magnetic field values are zero, the corresponding particle materializes. This represents a combination of wave theory and corpuscular theory.

Postulate number 10

Light propagates along a vortex path. The wave component includes the electromagnetic field, and at the zero point, where the electric and magnetic fields are zero, the particle materializes.

Postulate number 11

Vortex fields exist based on a determined spatial structure of the ether, or space itself. Ether possesses a specific geometric structure that includes vortex fields. Light is a vortex phenomenon and propagates in a precisely defined spiral form, where one aspect is wave-like and at zero-point junctions it is corpuscular. This process is generated from zero-point energy.

Postulate number 12

Each vortex spectrum has a cross-section represented as a mandala, and the numerical values within this mandala encode specific information. Every body possesses not

only a frequency spectrum but also a specific numerical information structure visible in its vortex spectrum.

Postulate number 13

The propagation of energy and information occurs exclusively through vortex movements. Vortex propagation is the fundamental connection between energy and information. Energy and information are not transmitted by strings; the vortex is the basis of a unified field. The real vortex field theory developed by Prof. Momchil Dobrev-Halachev since 1991 demonstrates the existence of vortex fields from atomic structures to stellar and galactic systems, as well as within the structure and functioning of the human body.

Postulate number 14

The cosmological theory of information demonstrates that vibrations form the basis of existence for all objects in the universe and for humans in particular, including the organs of the human body. These vibrations possess a vortex structure. Only vortex structures can propagate within space. The transmission, reading, writing, and modification of information in space and within the human body occur exclusively through vortex principles.

At the cellular level, clearly defined vibrations with precise frequencies and spectra exist. These vibrations are vortex fields. The reading and execution of information in DNA occur solely through vortex mechanisms. The vortex principle underlies the creation of planetary systems, with planets orbiting around a central sun. Each cell and organ vibrates with precise frequencies when healthy and different frequencies when diseased. Deviation from the healthy frequency interval indicates illness.

Vortex fields carry, transmit, and generate both information and energy, allowing conversion between them. Based on vortex field theory, processes of materialization and dematerialization occur without loss of information. Vortex fields are also the basis of matter and antimatter. Three principles apply to all vortex systems: a central commanding force, forces directing the structure inward toward the center, forces directing it outward, and a limiting force that defines the structure's boundaries. Hurricanes exemplify vortex structures, with calm energy at their center representing zero-point energy.

Basics of the theory of the universum

This section outlines the basics of the theory of the universum developed in 2005 by Prof. Mariola Garibova and Prof. Lord Momchil Dobrev-Halachev, together with the foundations of the cosmological theory of information and vortex field theory developed by Lord Prof. Momchil Dobrev. These theories include a critique of relativity theory and a supplementation of quantum theory, forming a unified theory of the universe.

Development of the cosmological theory of information and vortex field theory

In 1991, Momchil Dobrev created the Cosmological Theory of Information (Dobrev, 2009) and the Theory of Vortex Fields (Dobrev, 2012), which are presented as the basis of all existence. In the same year, Momchil Dobrev created two free-energy generators using the theoretical and practical foundations of these theories and built working prototypes. He deliberately refused to initiate mass production, stating that scientists and inventors who create such generators are often killed shortly thereafter.

The real vortex field theory proves the existence of swirling fields in the formation of matter at all levels, from atomic structures to stellar systems and galactic systems of the universe. Vortex fields are also present in the structure and functioning of the human body.

The cosmological theory of information proves that vibrations form the foundation of the existence of all objects in the universe and of human beings in particular. Even at the cellular level, there are precisely defined vibrations with precisely defined frequencies and frequency spectra. Events related to superconductivity discovery (1985)
In February 1985, Momchil Dobrev, under the leadership of Professor Karl Heinz von Gotte, discovered superconductivity. Due to intervention by a Bulgarian state security agent working at the Bulgarian embassy in Berlin, as well as interference from the U.S. CIA, research materials were stolen and betrayal occurred. Momchil Dobrev refused cooperation and was subsequently forbidden from publishing the discovery.

As a result of this intervention, Prof. von Gotte and Momchil Dobrev were not awarded the Nobel Prize in Physics. Two years later, the Nobel Prize was awarded to two scientists from Switzerland for the discovery of superconductivity in September 1985—seven months after the work of Prof. von Gotte and Momchil Dobrev.

Properties and principles of vortex fields

Vortex fields carry, distribute, and create both information and energy. There exists a direct conversion between information and energy and vice versa. Based on vortex field theory, materialization and dematerialization occur without loss of information. Vortex fields form the basis of both matter and antimatter and emit vibrations within precisely defined intervals.

This establishes the relationship between vortex field theory and the cosmological theory of information. Three fundamental principles apply to every vortex system:

1. A central force exists at the core of the vortex that governs the entire structure.

The propagation of energy and information occurs exclusively through spiral vortex movements with right-handed rotation. This is the simplest and most accurate way to describe and predict the behavior of energy and information in the universe.

Energy and information are transmitted in the same manner. They are not transmitted by strings. The vortex field and its forms constitute the basis of the single unified field.

Consciousness, dimensions, and harmonic universes

All vibrations possess a vortex structure. Only vortex structures can propagate through space, including the cosmos. The transmission of information through space occurs solely according to vortex principles.

The two theories assert that human thought can act as a carrier of both information and energy and can cause changes at both material and spiritual levels.

There are twelve dimensions of consciousness, each corresponding to specific types of vortex fields. Only the first density level, encompassing the first, second, and third dimensions, includes our incarnated physical self.

Each density level corresponds to a specific type of matter and a specific type of consciousness, defined as an information field with a particular informational structure.

In the first harmonic universe, which includes Earth, biological structures are carbon-based and matter exists on a purely physical level. In deeper harmonic universes where souls reside, biological structures are silicon-carbon based, and matter exists on a physical-etheric or semi-etheric level. In the third harmonic universe, beings are composed of crystalline silicon and matter is entirely etheric.

In the fourth harmonic universe, corresponding to current higher levels of consciousness, biological structures consist of crystalline liquid light, and the particles at that level are called premastery.

Higher dimensions and soul structure

Dimensions 13, 14, and 15, across five density levels, are composed of antimatter distinct from known antimatter, and the biology of beings at these levels is described as crystalline light radiation.

Above these dimensions are three additional levels—Polaris, Triadic, and Ecuatec—where beings exist as pure consciousness. These levels are not classified as dimensions.

The human soul consists of one core identity and eleven incarnated personalities, totaling twelve. Together with eleven other souls, one forms an air, comprising 144 incarnated personalities.

Twelve airs form a Christ avatar, containing 144 individuals and 1,728 incarnated personalities. Twelve Christ avatars form one Rhesus Adept. The relics of an Adept include an additional 144 airs, 1,728 individuals, and 20,736 incarnated personalities.

Time vector and energetic pairing of soul personalities

All twelve personalities of the soul are arranged within a time vector, similar to positions on a clock dial. This arrangement forms six paired personalities: 1 and 7, 2 and 8, 3 and 9, 4 and 10, 5 and 11, and 6 and 12.

The greatest amount of energy is concentrated in pairs 12 and 6, as well as pairs 3 and 9. These are referred to as the “ethical faces of the soul.” Most often, position 12 is male and position 6 is female, and they share the same DNA template.

Clearing and strengthening the connection with one’s own avatar enhances the biofields of all personalities and provides protection against negative intrusions up to twelve dimensions.

Whirlwinds, vibrations, information, energy, and consciousness

Both the vortex field theory and the cosmological theory of information demonstrate that human thought can act as a carrier of both information and energy and can cause changes at both material and spiritual levels. Experimental tests supporting this claim have been conducted at the Scientific Research Institute Dobrev-Halachev AD.

According to the cosmological theory of information, reaching the chakras of the fourth and fifth dimensions of the soul requires raising vibrational frequencies. This process was historically achieved in Egypt using specialized generators.

When a person raises their vibration and, with closed eyes, directs their gaze below a 45-degree angle, a light beam with a specific vibrational frequency is generated. This beam passes through a specific symbol—the Ankh, known from Atlantis and ancient Egyptian culture—which facilitates elevation and energetic transition.

There are twelve dimensions of consciousness, each based on specific types of vortex fields. Consequently, the DNA helix is double and counterclockwise. Information is read and written in DNA in one single direction only. This direction is associated with energy generation and the maintenance of vortex fields. The symbolism of snakes in antiquity represents this informational reading force.

Movements in the atomic nucleus

Electrons move within an electronic field. An electron materializes as a particle upon leaving the atomic field. The atomic nucleus generates a vortex field and rotates with a precisely defined vibration corresponding to both the nucleus and the electron field.

Each atom vibrates within a specific frequency spectrum and possesses its own characteristic vibration.

Motion systems in the solar system

The solar system exists based on rays that propagate along Fibonacci trajectories of the golden ratio toward the outer boundary of the solar system and return along the same path toward the Sun. Along these rays, vortex fields move, and planets follow concentric circular paths.

Perpendicular to the plane of planetary motion, from the center of the solar system to its boundary, exists a stabilizing field that closes the system and maintains its stability.

Ether as the medium of light

The ether is the medium through which light propagates.

Origin of gravity

Gravity is the result of vortex motion within the solar system and the vortex motion of the Earth around its axis.

Whirlwinds and vortex manifestations

Chakras are vortices. Rotational motion accelerates the field, and the center of this rotation generates free energy. Based on these principles, Prof. Momchil Dobrev created two free-energy generators in 1991.

Ether is the essence of space and the medium for light propagation. Gravity arises from vortex motion.

Various types of vortices exist, including linear vortices, planar vortices, and electromagnetic vortices. Light is a linear vortex. The electromagnetic wave is a vortex phenomenon.

Neutrinos carry information. An electron is a materialized manifestation of electronic space and materializes when leaving the atomic field. Nuclear rotation generates vibrations. Vortices possess different properties and interact according to vortex-based dynamics, including interactions described by Feynman-type schemes.

The world as a fluid system

The world is fluid in nature. Space itself is a fluid medium. Just as the speed of sound is precisely defined within the fluid medium of air, and the speed of propagation in water is defined by the aqueous medium, the speed of light is precisely defined by the fluid medium of the ether.

Cyclones and typhoons are fluid systems with a central element. Galaxies are fluid systems with stars at the center of their vortices. Plasma is a fluid. Different types of fluids create different spatial structures.

Fluids may be homogeneous or heterogeneous, electrically neutral or magnetized, ionized (plasma), or complex combinations thereof.

Space is a fluid and represents a closed system—the universe. Vacuum itself is a heterogeneous fluid.

Hyperbolic geometry applies to physical space. Sound waves and electromagnetic waves are vortex fields. Space possesses vortex characteristics and has field, quantum, material, informational, and conscious properties.

Every vortex carries information. Space contains open and closed vortices of various forms, including point, linear, and planar vortices. The laws of thermodynamics apply to fluids and therefore to space itself.

As temperature decreases, particle velocity decreases faster than volume, resulting in an increasing ratio of

radius to velocity. This demonstrates expansion and serves as evidence of an expanding universe.

Closed vortices take various forms, including the quantum and the universe itself. The first duality is space and motion. The first manifestation is current within space. When space moves, it exhibits a unique property—absence of friction—allowing it to preserve momentum indefinitely.

Forces in space, the universe, and the galaxy

When space moves, two fundamental forces arise:

- The force that causes movement, representing the aspiration of space toward impulse.
- The force that resists movement, representing the aspiration of space toward inertia.

The aspiration toward movement outweighs the aspiration toward inertia. Inertia acts as a braking force, slightly distorting motion. As a result, motion eventually returns to its point of origin and forms a rotating circle, such as those observed in solar systems, galactic systems, and atomic systems.

The first movement is a current within space. After long periods of time, this current returns to its point of origin and forms a closed circular belt. This belt rotates within a plane and maintains constant rotation.

Rotation in a single plane continues until the internal stress it generates produces a new movement at a right angle to the first, initiating a second current in space. This process repeats, resulting in two rotating planes, one nested within the other. The second plane forms beyond the first and therefore has a larger diameter.

The evolution of systems depends on the size and difference between these planes. When the newer plane acquires the same speed as the older one, attraction occurs, drawing the older circle toward the newer one.

Each circle possesses an upper and lower surface. The upper surface of the ascending arc may be considered positive, while the lower surface of the returning arc may be considered negative. In the second emerging circle, the polarity is reversed.

These circles attract and repel one another. The upper surface of the ascending arc of the first circle rises toward its corresponding aspect in the second circle, while the lower surface presses downward. This interaction generates a second movement composed of rotating disks.

When this second movement completes its first cycle and stabilizes its rotation, a new cosmos emerges. This marks the origin of a cosmos.

The secondary rotation of the first circle forms a ring that cannot be moved. The second formation establishes a

spherical boundary known as chaos. This outer sphere, although rotating, represents the primary calmness and immobility for that cosmos. It serves as the framework that assimilates force and enables momentum.

The ring referred to as chaos arises from the reaction of the primal force seeking impulse. It rotates at right angles to the primary rotation and counteracts it. The attraction of the ring-chaos establishes the ring-cosmos in secondary motion, forming the first restriction of every universe, galaxy, solar system, and atom.

This original movement enables space to emerge. According to the law of counteraction, the first impulse generates a secondary impulse that produces stability. Secondary rotation is a reaction to primary rotation, and restriction functions as supportive limitation, allowing pressure, concentration, and structure to arise.

Any progression toward a higher plane is a reaction to constraint.

The original rotation of the ring-cosmos generates counteraction, giving rise to the ring-chaos. The attraction between them forms the ring-space, which establishes the boundary that cannot be crossed.

This motion within ring-space, rotating in a plane and simultaneously around an axis, defines the limits beyond which creation cannot pass. This sphere is governed by two power lines: ring-space and ring-chaos, rotating at right angles to one another.

The rotation of the ring-cosmos is the source of evolutionary impulse, while the rotation of the ring-chaos is the source of restriction. The ring-chaos belongs to outer space, while the rings of ring-space face inward toward the enclosed sphere.

Ring-space seeks expansion toward the center and hardening through contraction. Ring-chaos seeks expansion toward the periphery and dissolution back into its origin. If unchecked, ring-chaos would dissolve the sphere, while unchecked ring-space would lead to complete stasis.

These two opposing influences are the source of all power in space. Ring-space builds and consolidates, while ring-chaos disperses and prevents accumulation.

Power circulates through rotational angles in opposition. The angle of the primary plane is considered positive, and the opposing angle negative. In different spaces, the initial rotation may begin at alternative angles.

Within a galaxy, there are twelve rays and seven cosmic levels. Space consists of three fundamental rotating motions. Pure movement in space precedes all form. The primal movement that generates existence begins before any object exists.

Space is limited by the ring that cannot be crossed, which defines the boundary of galaxies, solar systems, and atoms. Two-directional movements exist: the ring-space and the ring-chaos.

These three movements form the first trinity, making three a fundamental number. All subsequent tensions arise from the interaction of:

- The force of ring-space striving toward the center.
- The force of ring-chaos striving outward.
- The force of the limiting ring that maintains balance.

The limiting ring derives from ring-space and is closer to its nature. Ring-space concentrates energy, while ring-chaos dissipates it endlessly into outer space.

Cosmic ring motion creates secondary vortices bounded by ring-chaos, forming a rotating disk with a fixed center that evolves into a rotating sphere. This system generates rotating radii known as rays, forming spirals that connect center and periphery.

Energy flows outward and inward simultaneously. The center represents synthesis and balance. Rays flow outward above and inward below, creating circular motion. There are twelve rays and seven concentric circles.

The intersections of rays and circles generate vortices through tangential motion at acute angles. Interactions occur between rings, rays, circles, tangents, and vortices, forming the full dynamic structure of space.

CONCLUSION

The article presents evidence that challenges Charles Darwin's theory of the origin of man, dialectical materialism, and Einstein's postulate that the speed of light is the maximum possible speed.

These conclusions are based on the experiments of Lord Prof. Momchil Dobrev involving consciousness and on the discovery of the law of informational energy gene adaptation in 2008 by Prince Lord Prof. Momchil Dobrev and Mariola Garibova-Dobreva.

This law forms part of the theory of the universe developed in 2005 by Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva. From this theory arise energy-information genetics, energy-information medicine, energy-information psychology, and energy-information psychiatry, all within the framework of the theory of the universum developed by Prof. Mariola Garibova and Prof. Lord Momchil Dobrev-Halachev in 2005.

The work further builds upon the foundations of the cosmological theory of information and vortex field theory developed by Lord Prof. Momchil Dobrev, which describe the basic structure of the universe, the ether, and the structure of the ether itself.
