Following these experiences, he developed experiments aimed at proving the power of consciousness and human thought, demonstrating that consciousness can create phenomena often described as miracles, enable materialization, and access the most distant regions of the universe.

Subsequently, Lord Prof. Momtchil Dobrev formulated his own theory of species, types, and levels of consciousness and their structure, describing them mathematically.

In 2008, Prof. Momtchil Dobrev and Prof. Mariola Garibova-Dobrev discovered the *Law of Energy-Information Gene Adaptation*, based on studies of the shapes, sizes, and characteristics of adopted children during their development. end and a curvature of 45 degrees at the other end (Figure 1; Figure 2).

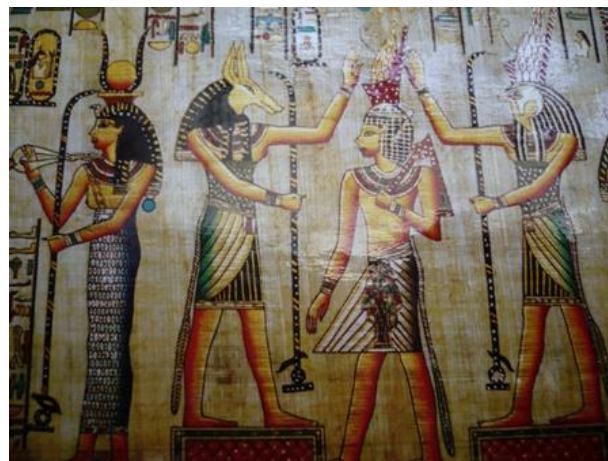

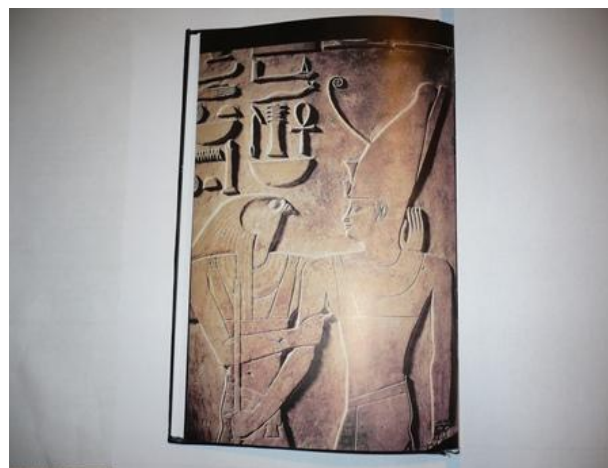

3. Theory and practice of consciousness: types, degrees, levels, topology, and metrics – the experimental studies of M. Dobrev

3.1. When listening to a precisely defined sequence of sounds that corresponds to and covers all frequency sound characteristics and matrices of each level of consciousness through the channel of consciousness, the eighth level of consciousness is reached without difficulty. At these levels, materialization occurs, particularly at the sixth level for negative thought forms, while materialization of positive thought forms occurs from the sixth to the eighth levels of consciousness.

The eighth level of consciousness is located harmonically within the corresponding harmonic matrices of the energy chakras that are harmonious with the main seven chakras in the third dimension of the human being. Thought can direct consciousness not only toward the structure of galaxies and stars but also toward the microworld. Through thought, consciousness can reach its destination instantly.

This is possible due to the fractal structure of the universe and the ability of consciousness to move instantaneously within corresponding structures, whether microstructural, megastructural, or otherwise.

Using these principles, Lord Prof. Momchil Dobrev opened the correct channel or portal, which any person can open to the universe and see what they wish, even if the object is billions of light years away. The

experiments conducted by Lord Prof. Momchil Dobrev are repeatable and yield identical results.

During this procedure, noise or shouting in the environment must be avoided, as such disturbances disrupt movement through the channel or portal and immediately return the individual to the physical body.

Based on the cosmological theory of information and vortex theory, Mariola Garibova and Momchil Dobrev developed the *Theory of the Universum* in 2005. In 2016, during a public lecture attended by more than 70 people, Lord Prof. Momchil Dobrev personally demonstrated the system and the method for opening a channel or portal, allowing participants to see any object in the universe instantly.

These experiments demonstrate that consciousness moves at an instantaneous speed, far exceeding the speed of light.

The model of consciousness includes levels, degrees, types, topology, and metrics. In 1991, Lord Prof. Momchil Dobrev conducted a series of experiments related to this model. Throughout the entire process, music combining harmonic frequency spectra of the third, fourth, and fifth dimensions is present.

The postulates derived from these experiments are as follows. Consciousness moves instantaneously at a speed far greater than the speed of light because it possesses a fractal-holographic structure characterized by the Fibonacci series and the golden ratio. Information at any single point is contained at every point in the universe. Consciousness can move anywhere at any moment, directed by human thought, with thought acting as the guiding force.

There are 13 levels of consciousness, with the soul having access to only 12 of these levels. Upon reaching these levels, an individual gains specific capabilities. At the sixth level, materialization of thought, intent, and desire becomes possible, including the healing of specific individuals. Sai Baba had access to the sixth level of consciousness, through which his thoughts and prayers resulted in materialized substances used for healing.

These conclusions are supported by the experiments of Lord Prof. Momchil Dobrev conducted between 1985 and 1991, as well as public experiments carried out between 2016 and 2017 in front of hundreds of participants.

4. At the Dobrev-Halachev Research Institute JSC, experimental testing has been conducted that confirms these principles. According to the cosmological theory of information, to reach the chakras of the fourth and fifth dimensions of the soul, vibrational frequencies must be raised. In

ancient Egypt, this was achieved using a generator (Figure 3).

According to the cosmological theory of information, when a person raises their vibrations so that, with closed eyes, a light beam is generated at a 45-degree angle with the appropriate vibrational frequency, that light beam and the closed eyes positioned at 45 degrees pass through a specific symbol—the ankh. This symbol, also known from Atlantis and the Atlanteans, represents elevation and the corresponding perception (Figure 3).

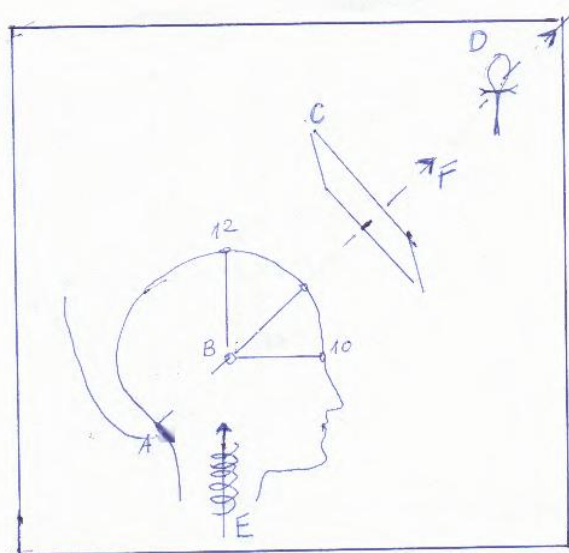

Another engraving that illustrates the process of resurrection and elevation is the depiction of Osiris' resurrection. In one of Osiris' hands, he holds a hook—a rod with a camber at one end, curved at an angle of 45 degrees. In the other hand, Osiris holds a bat, which functions as a vibrator.

The purpose of these objects is to stimulate the vibrational energy point of Confucius, which corresponds to the entry point of the thread to the soul of the individual. Only when this cycle is closed, and the stimulation of this point is achieved, does the process of elevation occur. This process can halt the reincarnation of the soul in the next life. It is a one-time process that must be synchronized with the harmonized frequencies of the universe.

The pineal gland acts as a gateway to both the energy and information realms of the universe. However, this portal can only be opened by following specific procedures. By comparison and analogy, this process is further demonstrated. The system of eight chakras in humans proves the capabilities of the human being to engage in these processes. Specifically, the three chakras associated with the pineal gland indicate that the angle between the third eye and chakra number 11 is 45 degrees (Figure 3).

Elevation involves lifting the vibrational frequency to heights corresponding to the fourth and fifth dimensions. These dimensions support the corresponding chakras, which serve as energy centers for every soul. When vibrations are released at frequencies corresponding to the fifth dimension, the elevation process is naturally achieved.

5. Tools for accessing the information field of the universe, the souls, and for potential reliquary or information drawing

There are three primary tools used for this purpose (Figure 4, Figure 5).

The first symbol is Ankh. This symbol, commonly known as "the key of life," "the Nile's key," the "life band," "the node of life," "the Egyptian cross," is called U + 2625.

In the traditions of Egypt, this symbol symbolizes the birth of the life of life. This symbol combines two symbols - a cross, that is the symbol of life and a circle as a symbol of eternity. Together, the two symbols indicate immortality. This offends the insult of the female and male deity, Osiris and Isis. It is a union between the earthly and the heavenly.

The UAC symbol denotes power. It is related to the Ankh and Jed symbols and depicts a rod held by pharaohs, gods, and other influential figures. This rod has been used both as a symbol of authority and as a device for generating cosmic healing power.

The Jed symbol represents a generator of precisely defined frequencies. It consists of a vertex, a vertical structure, a characteristic shape, and four well-defined horizontal “lines.” These four horizontal “plates” form a structure for generating energy, which accumulates between the plates. In fact, a standing wave or vortex exists between the plates, acting as a battery for energy storage. From the base to the first plate, this system functions as a method for transmitting energy.

A bas-relief combines all three symbols—the UAC, Ankh, and Jed—along with the symbols of a snail and a vessel. The snail represents a vortex wave. Together, these symbols generate vibrations that transmit precisely defined energy at a specific point, unlocking resonance to produce energy and access other dimensions. This process enables the generation of energy for building large objects, unlocks cosmological irrationality for healing, and opens the fourth, fifth, and other dimensions for accessing information in the universe.

6. Proceeding of removing, resurrecting, and receiving information from the spiritual world, and thinking processes

The pituitary gland is the organ that connects humans to the spiritual world and to the informational world of space and the universe. It also connects thought to its actual function of generating energy and information, allowing the acquisition of knowledge to influence and modify energy processes and phenomena.

In ancient Egyptian civilization, the process of elevation involved placing the rod at point A, which corresponds to the connection between the thread of the spirit and the physical body. The corresponding vibration was generated to produce energy directed toward the pituitary gland (point B) and positioned below 45 degrees to pass through 11 chakras. This energy then passes through the human mental screen and the Ankh symbol, where it can process information and perform other functions.

The mental screen is a horizontal plane less than 45 feet in width in the human visual field. It acts as a conduit through which energy and thought must pass. If the thought is aligned with high-frequency vibrations, it can pass through the Ankh, the symbol of life (Figure 6).

A crucial condition in this process is the generation of sufficiently high vibrations to open the respective channels and access subsequent dimensions, including the fourth and fifth dimensions. This enables greater access to higher energies and the collection of information from the spiritual world.

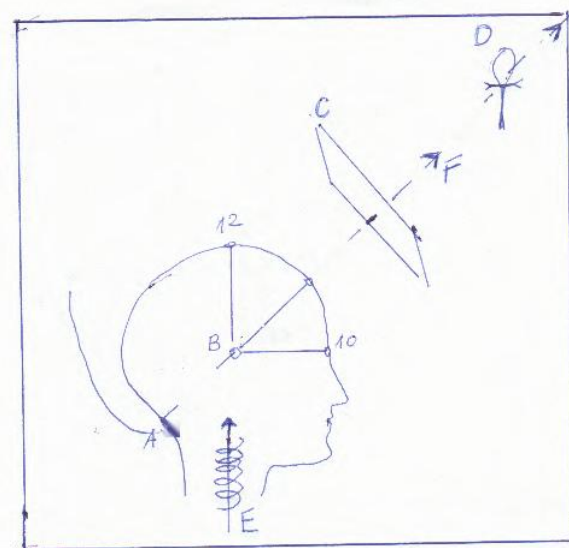

The procedure to be followed during the lead time is based on the generation of vibrations and light energy in the vortex field of the human pituitary. The high-field whirl, generated only by light waves and low-frequency excitation, can open the channel to access the fourth, fifth, null, and other higher dimensions.

Based on the cosmological theory of information and vortex theory, it is only through the interference of the leading signal and the channel of the corresponding dimension that human thought can continue along the path of entering deeper and higher dimensions of the universe and the spiritual world.

It is important to note that only when the light vortex field, with the corresponding high vibration, enters the Ankh symbol, can human thought gain energy and information access to the higher dimensions.

This parallel between Egyptian drawings and the achievements of the cosmological theory of information and the theory of vortex fields of Momchil Dobrev demonstrates that the Egyptian civilization had the capability, knowledge, and experience to access higher dimensions of the dual-ecumenical world. This proves the advanced development of this civilization compared to modern civilization.

The knowledge of these processes also suggests that the Egyptians, as well as pre-Egyptian civilizations such as Atlantis and the proto-Bulgarians and Thracians, had access to energy sources, telepathy, teleportation, and antigravity. According to the cosmological information theory and vortex theory, this knowledge implies access to zero-point energy, free energy generators, and other sources. These processes were also used to unlock space-energy channels capable of universally healing every person.

Such processes can open channels to the fourth, fifth, and higher dimensions, enabling energy generation from the absolute, as well as teleportation and movement across worlds.

7. These experiments reject dialectical materialism and the statements derived from it. More than 20 years ago, Lord Prof. Momchil Dobrev rejected the basic laws of Hegelian dialectics.

Dialectical materialism is a scientific-philosophical worldview, part of Marxism, which describes the general laws of development of nature, society, and thinking. Its main tenets include:

- Human beings are material and objective.
- Human consciousness is a subjective reflection of objective reality.
- Being determines consciousness.
- Human existence is social, and humans are humans only as social units.
- The meaning of existence lies in historical consequences.
- Human society is divided into classes.
- The engine of historical development is class struggle.
- Tools of production are central, and owners exploit laborers who do not own production tools.

Experiments by Lord Prof. Momchil Dobrev prove that consciousness moves matter, and that consciousness is primary, while matter is secondary. Consciousness is the primary force, and all other movement is secondary.

Dialectical materialism, in reality, has been used by corporate and Masonic oligarchies to control societal, economic, philosophical, scientific, and technological processes.

Twenty years ago, Lord Prof. Momchil Dobrev rejected Hegel's idealistic dialectics, as documented in dozens of his publications.

Matter and consciousness:

Dialectical materialism is based on the primacy of matter, claiming consciousness derives from being. Matter is considered eternal, indestructible, infinite, and absolute. Its forms—movement, space, and time—are preserved despite continuous change.

Experiments of Lord Prof. Momchil Dobrev, combined with his theory of types and levels of consciousness and the theory of the universe, prove that consciousness determines being. Consciousness is primary and creates matter.

This has been demonstrated at the gene level through research by Lord Prof. Momchil Dobrev and Prof.

Mariola Garibova-Dobрева, particularly through the law of gene energy-informational adaptacy, which shows that consciousness causes and creates matter.

Twenty years ago, Lord Prof. Momchil Dobrev refuted the three basic laws of dialectics:

- **Law of unity and struggle of opposites:** Dobrev proved that there is no inherent struggle between opposites; rather, there is interaction that leads to a higher level of harmony and consciousness. Dipoles are the basic structure of matter.
- **Law of the transition of quantitative accumulations into qualitative changes:** Dobrev demonstrated that quantitative accumulation does not lead to qualitative changes unless it occurs at a conscious level.
- **Law of negation of negation:** Dobrev proved this law to be insufficient and illusory, lacking true causality.

The hidden ideology of financial-banking, resource-technological materialism, as analyzed by Lord Prof. Momchil Dobrev, differs from the historical materialism of Hegel or Marx.

Critique of Hegel and Marx:

- **Thesis 1 – “In the beginning there was matter”:** This asserts the primacy of matter without evidence, whereas Dobrev's theories (cosmological theory of information, vortex field theory, free energy theory, energy-information medicine, theory of the universe, energy-information genetics, psychology, and psychiatry) demonstrate that spirit, consciousness, and thought are primary, followed by matter.
- **Thesis 2 – “Being determines consciousness”:** This suggests economic conditions determine individual thought and personality. Dobrev's theories show that consciousness and thought determine being, not vice versa.

Even Sigmund Freud criticized Hegel and Marx, noting that different individuals, races, and nations behave differently under identical economic conditions, disproving the absolute influence of economic factors. Based on this erroneous theory, Marx developed historical materialism, asserting that property and means of production dictate the course of history and the formation of social classes.

Dobrev's analysis of financial, banking, and technological history since the 13th century shows that bankers and financiers, through creating conflicts and wars, have been the real drivers of historical change.

Thus, the financial-banking, resource-technological materialism described by Lord Prof. Momchil Dobrev-Halachev reflects reality, while Karl Marx's historical materialism represents manipulation.

- **Thesis 3 – History as class struggle**

Marx asserts that all human history can be reduced to class struggle. He interprets history exclusively as a history of class conflict, with the exception of prehistory, and divides social development into distinct stages.

In reality, since the eighteenth century, it has not been historical materialism in the Marxist sense that has operated globally, but rather what Lord Prof. Momchil Dobrev defines as *financial-banking, resource-technological mafia-informed materialism*.

- **Thesis 4 – Class struggle and the dictatorship of the proletariat**

Marx further claims that class struggle necessarily leads to the dictatorship of the proletariat, after which all classes will ultimately disappear.

8. Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva

The Law of Energy–Information Gene Adaptation

The Law of Energy–Information Gene Adaptation, developed and experimentally studied by Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva, provides practical research evidence that consciousness, as an energy–information system, forms and creates matter, or commands the creation of matter through consciousness. This law presents a new view of physics, biology, and cosmology, and serves as evidence rejecting Darwin's evolutionary theory and dialectical materialism. The study demonstrates that consciousness functions as an energy–information mechanism capable of inducing gene adaptation.

Empirical observations and study design

The study proves the influence of the environment—specifically, the energy–information system of individuals and groups—on the energy–information system of a developing child or young person between the ages of 3 and 18.

Practical research conducted by Prof. Momchil Dobrev and Prof. Mariola Garibova-Dobreva shows that the following factors influence development:

- The thoughts of the individual
- The thoughts of others
- Energetic imprints from previous lives
- Energetic loads created in the present life
- External energy influences

When a child is in a developmental phase, the energy–information field of the parent with whom the child lives shapes and causes energy–information adaptation. This adaptation manifests in physical characteristics such as height, body size, thickness, and overall structure.

The energy–information field of the dominant parent determines the physical form of the child. Feelings of love, care, attention, respect, as well as verbal and

nonverbal communication, directly affect the child's physical development. When one parent is dominant, the child's physical form tends to resemble that parent.

Adopted children study

The research examined 33 families with adopted children:

- One-third were families with both parents raising the child until adulthood.
- One-third were families where one parent died or separated, with the child raised primarily by the mother after ages 7–13.

The results demonstrate the following:

- Adopted children develop body structure, muscle structure, volume, thickness, bone structure, limb proportions, and overall physique that closely resemble their adoptive parents.
- Growth patterns, including height and body proportions, correspond to adoptive parents rather than biological parents.
- No correlation was found between the physical characteristics of adopted children and their biological parents.
- Traits such as abdominal fat distribution in adoptive parents—particularly mothers—were consistently reflected in adopted children.

These observations were consistent across all 33 families studied. Due to the volume of data, only conclusions are presented.

Conclusions of the law

There is indisputable evidence of forced energy–information gene adaptive modification in adopted children, caused by the energy–information field of adoptive parents during developmental years (ages 3–18).

The energy–information field of the parent first forms the energy–information field of the child, which subsequently forms the child's physical, material body. This leads to the formulation of:

The Law of Formation of Matter from the Energy–Information Field of the Dominant

DNA expression depends not only on genetic code but also on the folding, twisting, or untwisting of genes, which is influenced by the surrounding energy–information field. Emotional states, thoughts, spoken words, and environmental energy fields directly affect DNA field structure and gene expression, especially during development.

The energy–information adaptation of a young person is strongest during growth and depends on the energy–information field of those with whom the child lives.

Final evidence

The field structure around DNA provides instructions on how genes are read and expressed. The environmental energy–information field shapes the DNA field structure itself.

Lower schematic representations (Fig.) illustrate these findings, where solid lines represent the adoptive parent and child, and dashed lines represent the biological parents. These visual models confirm that adopted children physically resemble adoptive parents rather than biological ones.

The conclusions are that the consciousness, which is the informational energy matrix of the human parent, influences the same consciousness of the adopted child. That is, there is a transfer of consciousness-information from one consciousness of one person to another consciousness of another person, which controls the gene of the child, which explicates and translates the information from the parent. Consciousness is the basic structure of the universe. Consciousness as an informational energy system creates and is the reason for the creation of matter – conscious matter.

8.1. law of consciousness–informational energy gene adaptation from 2008 by prince lord prof. momchil dobrev and mariola garibova-dobreva – real denial of darwin's theory

Darwin's theory of evolution is a scientific theory of the development of life on earth. According to this theory, the current diversity of species living on earth is a consequence of gradual processes that occur over a long period of time, during which organisms develop from simple to more complex, changing, adapting to the environment. According to darwin's theory of evolution, all organisms have a common origin from a single cell. The creator of the theory of evolution is charles darwin. In reality, the ground for this theory was prepared long before by other thinkers and creators. Before darwin, at the end of the 18th century, the scotsman james hatton (†1797) published the book “theory of the earth”. According to him, the current appearance of the earth should be explained by the slow action of uniform forces over a very long period of time. That the earth is old, millions of years old, although he does not dare to say exactly how many, is also the position of the famous british geologist charles lyell (†1875). In the same way, darwin's grandfather, erasmus darwin (†1802), also believed that all organisms on earth originated from a common ancestor. Even the french scientist jean-baptiste lamarck (†1829) was the creator of his own theory of evolution. This theory also preceded charles darwin's theory. It differs in its view of what the driving factors of evolution are. In contrast, darwin is considered systematic, analytical, and precise in his views and conclusions. He supported all this with research and several published works.

On november 22, 1859, darwin's book *the origin of species* (full title: *the origin of species by means of natural selection, or the preservation of favoured races in the struggle for life*) was published. In his book, darwin presented “a long argument” of detailed observations, conclusions, and discussed all possible counterarguments. At the same time, the only hint that darwin made about human evolution was in the restrained sentence: “light will be thrown upon the origin of man and his history.”

By this time, lyell had already popularized human prehistory, and huxley had demonstrated that, from an anatomical point of view, humans belonged to the group of anthropoid apes. In his book *the descent of man and selection in sex*, published in 1871, darwin presented evidence that humans belonged to the animal kingdom, illustrated the continuity of physical and mental traits, and proposed sexual selection as an explanation for the existence of useless traits in animals. He traced the evolution of human culture, the differences between the sexes, as well as physical, cultural, and racial characteristics. All this while emphasizing that all human beings belong to one species. His research continued in his work *the expression of the emotions in man and animals*. In this book, he discussed the evolution of human psychology and its continuity with animal behavior. The conclusion at the end of the book is: “man, with all his noble qualities, with all the sympathy he feels for the lowest, with his benevolence not only towards other people but also towards the humblest forms of life, with his godlike intelligence with which he penetrates the movement and composition of the solar system – with all his sublime faculties, man still bears in his bodily frame the indelible imprint of his lower origin.”

8.2. law of consciousness–informational energy gene adaptation – evidence for the denial of darwin's theory and dialectical materialism

The evidence from 2008 of the discovery of prof. momchil dobrev and prof. mariola garibova-dobreva proves that the influence of energy and information from the parent or parents who adopted a small infant child causes a real change in the child's physical and mental qualities, in the structure of his skeleton, the structure of his body, behavior, and everything else, which darwin's evolution cannot do naturally.

In the process of contact between the adopted child and his adoptive parents from a young age to his 18th birthday, all this change and shaping of the child's body – corresponding shapes, height, dimensions, physique, and others – is transferred by virtue of the energy–informational transfer of information from the parent to the adopted child.

These changes, which are precisely clear and proven, and which have nothing to do with the genetic data of the child from his real parents, could not have occurred as a result of darwin's evolution. The basis of any human

development is his informational–energy structure, hormonized in a precisely defined way. His development depends exactly on this energy–informational structure. There is actually a transfer of informational genetic information, which forms and causes a change in matter in the adopted child. The informational energy structure of man and the universe is the one that determines the development of man, both his evolutionary and momentary development.

9. consciousness as the first cause

Consciousness is this informational energy structure that governs matter and creates matter.

Theory of vortex fields and human energy: based on two types of treatments.

Universe theory: the combination of quantum theory and relativity with some corrections and new views on the vortex nature of space, cosmological information theory.

Forced gene information–energy adaptation:

- The reading of DNA at the same input information depends on the energy state of the human energy system – thoughts, feelings, subconscious, past lives, energy interventions from outside, energy karmic bases, and the constant influence of the energy field of another person who lives with the person under study.
- Regulation of gene activity depends entirely on the daily influence of:
 - a. The energy-information fields from the outside, including human energy-information fields of the environment, energy-information fields of the dwelling, the energy-information fields of the planet earth.
 - b. Human energy-information fields (consciousness)
 - c. Energy-information fields of food
 - d. Energy-information relations between people
 - e. Thoughts of the person himself (energy-information fields)
 - f. Thoughts of other people (energy-information fields)
 - g. Energy-information field of the earth and its influence
 - h. Hereditary information – energy–information
 - i. Energy-information fields from other dimensions
 - j. Energy-information fields of the environment
 - k. Energy-information state of individual cells (micro niveau)
 - l. Energy-information state of the whole human body
 - m. Long-term energy-information fields models (epigenetics)
 - n. Energy-information perception from the outside world and information to the brain and the limbic system
 - o. Energy-information structure of stress, fear, apprehension, sadness, anger, or other emotional blockages

- p. Energy-information structure of past experiences
- q. Energy-information blocks
- r. Energy–informational unconscious impressions, alarm reactions
- s. Thoughts, brain, consciousness, information field, physical matter
- t. Information field to the brain, physical matter

The regulation of gene activity depends on the environment in which a particular human energy system is located, the person, and with whom he lives. The gene is a fragment of the hereditary DNA molecule, which contains the building code of certain body parts. Each gene has a “gene trigger” – regulatory sequences. The regulation of a gene determines whether and in what quantity the corresponding protein is produced. The regulation of gene activity is not determined by the gene itself. In the brain, regulation of genes is subject to the constant influence of psychological signals, including thoughts, food, fields, feelings, past lives, and subconscious states.

10. basics of energy–information genetics, energy–information psychology, energy–information psychiatry, energy–information medicine, and energy–information archaeology

Based on the theory of the universum developed by prof. mariola garibova-dobrev and prof. lord momchil dobrev – halachev in 2005, including energy-information gene adaptation, the following disciplines are distinguished:

- Energy–information medicine
- Energy–information genetics
- Energy–information psychology
- Energy–information psychiatry
- Energy–information archaeology
- Energy–information physics

On the basis of the cosmological information theory and vortex theory, mariola garbova and momchil dobrev elaborated the 2005 theory of universum.

We will briefly state that, based on the research of the human energy system and how it affects precisely defined diseases such as the identification system and consequently as a method of therapy and healing, it has been proven that the chakras actually represent the human energy centers as double swirls that can rotate both on one side and the other. The interdependence of human energy is energetic in the environment at both the conscious and the subconscious level. It has been demonstrated that human states and diseases are connected to the state of the human energy system – chakras, energy flows, consciousness, and subconscious. In fact, diseases that have been studied by mariola garibova and momchil dobrev have found an easy and adequate explanation. This not only provides an explanation for the types of illness, but also gives a realistic guide to their therapy holistically – i.e., complex, physical and spiritual, i.e., energy-based.

Based on these studies, the following sections of medicine, biology, psychology, and genetics are distinguished:

- Energy-information genetics
- Energy-information psychology
- Energy-information psychiatry

Since the current article allows for such a voluminous viewing of matter that requires a monograph of at least 1500–2000 pages, we will give the results briefly below.

10.1. Consciousness and information

Information is the primordial essence that gives birth to everything and everything alive. Information is part of consciousness, which is a living system that stores, receives, renews, sends, and manages the processes, movements, and actions of life.

Consciousness, through information, influences the energy field and, accordingly, through it on matter. Consciousness, through information and based on signals from:

- The medium, through food
- The environment, including nature, plants, and animals
- The environment, including earth's energy-information field
- The medium, including the energy-information field of a person or another person
- The medium, including the energy-information field of the sun
- The environment, including the energy-information field of the universe
- The environment, including other people's energy-information fields
- The environment, including the subconscious, past lives, and past experiences

Consciousness and information are influenced, controlled, and commanded accordingly by energy fields, which in turn affect matter. There is an energy-information matrix (consciousness) on earth, in the sun, in the universe, and in humans.

Consciousness is an information field that is different for different types of density, depending on different dimensions of the field. Consciousness is an information matrix that corresponds to and is composed of the consciousness of different fields and field structures. For humans, depending on the fields, information fields have 12 dimensions of consciousness, the basis of which are types of vortex fields. Therefore, the DNA helix is double and counter-clockwise. Reading information from DNA occurs in that one and only direction. This is the direction of reading and writing information. Snakes in antiquity show the generation of the power that reads information. This is the direction of energy generation to maintain vortex fields.

The twelve – the six double threads – prove the existence of a 12-dimensional space – 12 dimensions of human DNA.

Based on these studies, prof. momchil dobrev won the 2021 world championship in fundamental physics, and prince prof. momchil dobrev and princess prof. mariola garibova-dobreva won the 2022 world championship in genetics.

This section describes studies of the team of prince prof. momchil dobrev and princess prof. mariola garibova, proving the truth about depression as a mental disorder, based on the theory of the universum developed in 2005, including the basics of cosmological theory of information and vortex field theory.

In 2006, both prince lord prof. momchil dobrev and princess lady prof. mariola garibova-dobreva developed energy-information medicine, energy-information genetics, and energy-information psychology.

Basic postulates following from theory of the universe, theory of vortex fields, energy-information medicine, and genetics

Postulate 1: Each organ oscillates in a specific spectrum when it is in a healthy state. The health spectrum is a specific interval called the healthy interval. When this organ radiates outside this interval, either above or below, the organ is sick. Every pathogen, bacteria, virus, and other emit in a specific interval spectrum, oscillate, and emit scalar waves.

Postulate 2: In the human energy-information system, there are frequencies for the regeneration of human DNA and each organ. The specific frequency and its harmonic regenerate both DNA and every organ of the human.

Postulate 3: Each organ has a frequency for the regeneration of its cells.

Postulate 4: Organ regeneration is carried out by modulation of the basic frequency, which regenerates the modulated DNA with the frequency of the organ. When the regeneration rate of cells of the respective organ is superimposed on the baseline carrier frequency of DNA regeneration, both cell regeneration and treatment are possible.

Postulate 5: Treatment of pathogens is possible through interference. Since each pathogen emits a specific frequency spectrum, generating the same spectrum directed at the pathogen causes interference that destroys it.

Postulate 6: The information code is a matrix emitted continuously by every living object, organ, or human body. It represents the cross-section of vortex radiation from the respective organ or object.

Postulate 7: The information code is read in a vortex, counterclockwise way.

Postulate 8: Treatment of a specific organ can be done either by interference with a frequency spectrum corresponding to the organ or through the information code transmitted in the same way.

Postulate 9: Distribution of particles, electrons, and other elements in circuits is done by alternating a wave drill with a particle. The wave center is a right clockwise turn of all frequencies of light; at zero points, the corresponding particle materializes. This combines wave theory with corpuscular theory.

Postulate 10: Light is distributed by a vortical path. The wave part includes the electromagnetic field, and at zero points, the particle materializes.

Postulate 11: Vortex fields exist on the basis of a determined spatial structure of the aether (space). Ether has a specific geometric structure, including vortex fields. Light is a whirlpool and propagates as a vortex spiral, wave in one part and corpuscular at points of zero union. This is generated from zero-point energy.

Postulate 12: Each vortex spectrum section is a mandala, whose numbers represent specific information of the relevant body.

Postulate 13: Energy and information propagate only through vortex movements. Vortex fields are the only way to spread energy and information. Energy and information are not disseminated by strings.

Postulate 14: Cosmological theory of information proves that vibrations are the basis of the existence of all objects in the universe, including humans, in the frequency organs of the human body. Vibrations have a vortex structure. Only vortex structure can propagate in space. Information is read, written, and changed in a vortex way. At the cellular level, there are well-defined vibrations with specific frequencies. Vortex fields carry, spread, and create both information and energy. Conversion between information and energy is possible. Vortex fields underlie materialization and dematerialization, material and antimatter. Vortex fields emit vibrations at well-defined intervals, connecting vortex fields with cosmological information theory.

Three specific principles apply to any vortex system:

- There is a central force at the base of the vortex that commands the entire structure.
- Vortex forces cause the structure to tend to the center or outward.

- A separate force limits the size of the structure, preventing objects from leaving it. Hurricanes are also vortex structures. At the center of hurricanes is peace – energy at zero point.

12. Basics of the theory of the universe

The theory of the universe was developed by prof. mariola gariova and prof. lord momtchil dobrev – halachev in 2005, including the basics of the cosmological theory of information and vortex field theory developed by lord prof. momtchil dobrev – criticism of relativity theory and supplementation of quantum theory.

Basic principles of the theory of universe – unified theory of the universe, critique of relativity theory, and supplementation of quantum theory

In 1991, momchil dobrev created the cosmological theory of information (dobrev, 2009) and the theory of vortex fields (dobrev, 2012), which are the basis of everything. In the same year, momchil dobrev created two free energy generators using the theoretical and practical solutions of both theories, creating prototypes, but refused to start regular production because he knew that scientists and inventors creating such generators were soon killed.

The real vortex theory proves the existence of swirling fields in the fabrication of matter at the lowest to the highest levels, from the atomic structure to star systems and galactic systems of the universe. On the other hand, vortex fields are also present in the construction and functioning of the human body.

The cosmological theory of information proves that vibrations are the basis of the existence of all objects in the universe and humans in particular. Even at the cellular level, there are precisely defined vibrations of precise frequencies and frequency spheres. Each cell, even every organ, vibrates with exactly the same frequency when in a healthy state, and with other frequencies when in a diseased state. The deviation from the interval norm of "healthy" body vibrations proves that the body is sick.

In February 1985, momchil dobrev, under the leadership of professor karl heinz von gotte, discovered superconductivity. However, due to the intervention of a bulgarian state security agent working at the berlin embassy and the us cia, materials were stolen and betrayed. Momchil dobrev refused and was forbidden to publish the discovery. Consequently, in 1985, prof. gotte and momchil dobrev were not awarded the nobel prize in physics. Seven months later, in september 1985, the nobel prize was awarded to two swiss scientists for the discovery of superconductivity.

Vortex fields carry, distribute, and create both information and energy. Conversion of information into energy and vice versa is possible. The vortex fields are

the basis of matter and antimatter. Swirl fields emit vibrations at precise and specified intervals. This is the relationship of vortex fields with the cosmological information theory.

Three distinct principles apply to each swirling system:

- There is a force at the center of the vortex that controls the entire structure.
- Swirling forces cause the structure to strive for the center and external propagation.
- A separate force prevents objects from leaving the structure, limiting the size of the system.

Vortex structures include hurricanes, which have a calm center.

There are chakras in the human body at the physical level and two other levels. These chakras supply information and energy to the respective glands, levels, and organs, while also raising energy to the highest level. The whirling structure radiates corresponding vibrations.

Light is a vortex. Each electromagnetic wave is a whirl, with the point at which both the electric field and magnetic field are zero. The space generating the vortices is geometrically based on the golden section, including the numbers phi and pi. An electromagnetic wave is a whirlwind in a straight line.

A basic element in the cosmological theory of information is the single field, which is based on vortex fields. The dissemination of energy and information occurs through spiral, right-rotating movements. This is the connection between information and energy, as both are transmitted in the same way. Energy and information are not distributed by instruments. The vortex field and its forms are the basis of the single field. Vibrations have a swirling structure. Only vortex structures can spread in one space, such as the cosmos. Spreading information into space occurs purely by the whirlwind principle.

The two theories prove that human thought can be a carrier of both information and energy and can cause changes at material and spiritual levels. There are 12 dimensions of consciousness, based on types of vortex fields. Only the first density level (first, second, and third dimensions) contains our incarnate self.

Each density level corresponds to a type of matter and consciousness – an information field with an information structure for that level. The first harmonic universe, or that of earth, has a biological structure based on carbon, and matter exists on a physical level.

In a deeper harmonic universe, where our souls inhabit, there is a silicon-carbon biological structure, and matter exists on a physical-etheric or semi-etheric level. In a third harmonic universe, creatures are composed of crystalline silicon, and matter is entirely etheric.

The biological structure of the fourth harmonic universe, where current levels of consciousness are found, is "crystalline liquid light," and the particles are called premastery. Dimensions 13, 14, and 15, at five density levels, are composed of antimatter, and the biology of beings is called "crystalline light radiation."

The three levels above these dimensions – polaris, triadic, and ecuatic – are beings of pure consciousness and are not considered dimensions. Our soul includes us and eleven incarnated personalities, totaling twelve people.

Our soul, together with 11 others, forms our aura. Accordingly, the aura is composed of 144 incarnated personalities. Twelve halves make up the christ avatar, which includes 144 people and 1,728 incarnate personalities. Twelve christ avatars together form one rhesus adept.

The relics of the adept include 144 breaths, 1,728 people, and 20,736 incarnate figures. All 12 personalities of the soul are placed in the so-called time vector, arranged as a clock on a dial. Six pairs of born persons are formed: 1 and 7, 2 and 8, 3 and 9, 4 and 10, 5 and 11, 6 and 12.

Most energy is allocated to pairs 12 and 6, as well as pairs 3 and 9. These personalities are called the "ethics faces of the soul." Most often, position 12 is a man and position 6 is a woman, with the same DNA template.

Clearing the link with your own avatar helps strengthen biofields and creates protection from negative intrusions up to 12 dimensions.

Gravity is the result of the vortex motion in the solar system and the vortex motion of the earth around its axis. The forces in space, the universe, and the galaxy arise when space moves. There are two forces:

- a) the force that makes it move, being the aspiration of space for impulse
- b) the force which had hitherto kept it from moving, being the desire of space for inertia.

The pursuit of movement outweighs the pursuit of inertia. The pursuit of inertia acts as a brake on motion, so the movement is slightly distorted. Therefore, in the end, it returns to where it started and forms a rotating circle, such as the solar system, the galaxy system, and the atomic system.

The first movement is a current space. After aeons, it returns from where it left. This makes a holiday round belt. This belt rotates in a plane with constant rotation. The rotation in one plane continues until the stress it creates causes a new movement and starts a new current in space at right angles to the first. The same process is repeated.

We now have two rotating planes, one inside the other, with the second plane formed beyond the first, so its diameter is larger. The whole evolution depends on the difference and size of these planes. When the higher acquires the same speed as the smaller and older, it begins to attract an aspect of it, causing the older circle to be drawn to the newer one.

The first circle should be considered as having an upper and lower surface. The upper surface of the upstream arch is positive and the lower surface is negative. The downward arc is the opposite. The same applies to the second emerging circle.

These circles are mutually attracted and repulsed. The upper surface of the ascending arc of the first circle ascends to its corresponding aspect in the second cycle, and the lower surface of the returning arc presses down, creating a second movement divided by rotating disks. When this second movement completes its first lap and establishes steady rotation, a new cosmos occurs. This is the origin of the cosmos.

The secondary rotation of the first circle is the ring that cannot be moved, and the circle of the second formation is the sphere that sets the boundary of the sphere, the so-called chaos. There is a secondary branch on the outer sphere, which, though it is a rotating circle of motion, represents primary calmness and immobility for that cosmos. It is the framework of the power of komsom, which assimilates and allows momentum to be acquired. The ring, the so-called chaos, arises from the reaction of the primal force to obtain its impetus. It rotates at right angles to the primary rotation and counteracts it. The attraction of the ring-chaos establishes the ring-cosmos in its secondary motion, forming the secondary rotation we call the ring, which cannot be moved. This is the first restriction that limits every universe and galaxy.

In essence, this is the original movement that enables space to emerge. The law of counteraction states that the first impulse breaks a secondary impulse, so the secondary impulse, in contrast, creates stability. Secondary rotation occurs as a reaction to the primary rotation. Restriction functions as a display support. It should be understood as a limitation that allows pressure and concentration to emerge. Any progress toward a higher plane is a reaction to this constraint.

We have the original rotation of the ring-cosmos. The counteraction gives rise to the ring, the so-called chaos. The attraction of the ring-chaos causes the secondary rotation of the ring-space, forming the ring that cannot pass. This motion in the ring-space, rotating in a plane and simultaneously rotating as if on an axis, sets a boundary beyond which creations of the sphere cannot pass.

This sphere is defined by two power lines – ring-space and ring-chaos – rotating at right angles to each other.

The rotation of the ring-cosmos is the source of the force from which evolution derives its impulse, and the rotation of the ring-chaos is the source of the force from which restriction draws its power. The ring-chaos belongs to outer space, not the dangerous sphere. The rings of the ring-space face the sphere they encircle.

The aspirations of the ring-chaos are turned to the surrounding space. The ring-space seeks to expand the center. The ring-chaos seeks to expand the periphery. The ring-space seeks to harden by contraction. The ring-chaos seeks to return to the point from which it arose. If its influence were unimpeded, it would reduce the sphere in danger. The ring-space, if unimpeded, would remain static.

These two influences are the source of all power in space. The ring-space, because it hardens, builds. The ring-chaos, because it scatters, never grows. Power circulates through a rotating angle relative to each other, creating opposition. The angle of the first rotation is called "positive," and the opposite angle is called "negative." Another space may have its first plane start to rotate at another angle, the angle of "negation."

In one galaxy, there are twelve beams and seven cosmic levels. Space consists of three rotating motions. Movement in space is pure movement. The primal movement that gives rise to all that exists begins before there is anything that moves. Space is limited by this movement, called the ring that cannot be moved. This is the limit of any galaxy, solar system, or atom. There are also two-way movements: the ring of space and the ring of chaos.

These three movements form the first trinity, understood as the supreme being in a new manifestation. Three is a fundamental number. Subsequent tensions cannot balance these three forces:

- The power of the ring-space, which strives for the center
- The power of the ring-chaos, which strives for outer space
- The power of the ring that cannot be crossed, which maintains balance between them

The ring that cannot be transmitted derives from the ring-space and is more a part of its nature than of the ring-chaos. The space ring focuses energy while the chaos ring dissipates energy. The chaos ring cannot build anything because its generated force is indefinitely dissipated.

The motion of the cosmic ring creates secondary vortices. It is bounded by the ring-chaos, so the inward band expands into a rotating disk with a fixed center. In practice, this becomes a rotating sphere. This system gives rise to rotating radii, which we call rays, forming a spiral connecting the center to the periphery. Streams flow from the periphery to the center. The center is the

synthesis and balance of all forces. Rays flow outward at the top and inward at the bottom, creating circular motions. The rays are twelve, and the concentric circles are seven.

Tangents are formed where circles and rays intersect, generating vortices and tangential motion at acute angles. Rings, rays, and concentric circles interact, creating movement on tangents and within vortices.

13. CONCLUSION

In ancient Egypt, they knew the process of resurrection and elevation. They understood not only the construction of the spiritual world but also the vortex fields, the zero point, and the generation of energy. Everything above proves that ancient people, as shown in other studies, used literature and knowledge that challenges Charles Darwin's theory of the origin of man, dialectical materialism, and Einstein's postulate that the speed of light is the greatest.
