Request to order Law of RICO and your order from 2017 regarding the magistrates Vladimir Valkov, Stoyu Zgurov, Klaudiya Mitova, Radina Kaleva, Aneliya Yaneva, Chanacheva, V. Hristakiev, Elena Arnauchkova, Aleksei Trifonov, Daniela Doncheva, Lozan Panov,

Rusi Alekseev and other politicians and statesmen, prosecutors, judges – attached.

This is yet another proof of mafia fascism in the Sofia City Court and Sofia District Court, Sofia Court of Appeal and Supreme Court of Cassation – regarding and concerning missing since 2004 court cases against banks, insurers, thefts of slot machines against Judge Jordanka Borisova Mollova and her lover Hristo Borisov Mollov, Sabina Angelova, theft of property for 850 million euros inheritable our property by Emil Kyulev and Donev and other persons; the inaction of the chairmen of Sofia City Court Svetlin Mihaylov, Georgi Kolev, Yaneva, Evgeni Georgiev, Kaloyan Topalov, Vladimir Yordanov, Alexey Trifonov, Rusi Alekseev; the chairmen of Sofia Court of Appeal Pengezov and Daniela Doncheva; the inaction of the presidents of the Supreme Court of Cassation Lozan Panov, Krasimir Vlakov (now a constitutional judge), Galina Zakharova, Prof. Lazar Gruev; the inaction of the Prosecutor's Office under Prosecutor General Assoc. In 2016, 2019 and 2020 I informed you through your ambassador to Bulgaria - Mrs. Hero Mustava - about the mafia in Bulgaria in the judicial system, in court, prosecutor's office in the state under the administration

of the minister of justice Boyko Borisov, about the orders for my murder by both General Lyuben Gotsev and minister of justice Boyko Borisov, prosecutor general Sotir Tsatsarov, judges Raina Martinova, Alexey Trifonov, Rusi Alexiev, about the missing court cases for the theft of tens of millions - hundreds of millions of dollars from banks, about the missing cases against insurers and the theft of our hereditary properties by poisoned and banks property of the Freemasons - Illuminates, as well as the cases intended by order of the mafia against the property of "Principality Dobrev Halachev Dynasty" since 2013 without a single court hearing from the bargains and Tsvetan Bankov with millions of leva received as a syndic and properties for millions - without a single court hearing with the ultimate purpose the theft of our property, which is confirmed by the following events:

As a cover of all from 2011 there were 17 (seventeen) attempts to murder Prince Lord Academic Prof. Momchil Dobrev, the true fighter against lawlessness, corruption, the mafia, not only in Bulgaria, but also in the European Commission, which supports this mafia.

Case study beginning

On 04.04.2008 and 21.05.2008, by virtue of the award decrees, D. acquired the property located in the Northern Tangent of the city of Sofia - the capital of Bulgaria - with areas of 2050 acres and 2170 acres respectively.

As early as September 2008, pressure began on the father by phone from 11 pm to 3 am, with D.D. being invited to donate the property to the then prime minister Boyko Borisov and threats. After these threats, D.D. suffered a stroke, a heart attack and broke his leg in the hospital in the city of Burgas. Since September 2008, after an operation in a hospital in Sofia, D.D. has been bedridden in the city of Sofia.

After threats and extortion against the D. family did not work out, former colonels from the state security, posing as representatives of the prime minister B.B., began to want to buy the properties at a price 9000 (nine thousand) times below the market price.

After the refusal of this proposal, actions were taken in various institutions.

Following letters from the chairman of the Chamber of Private Enforcement Agents Georgi Saykov Dichev to the National Revenue Agency, to the prosecutor's office, to the Sofia City Prosecutor's Office, decrees were issued by prosecutor Mariyana Stankova from the Sofia City Prosecutor's Office to appoint tax audits.

After colonels from the State Security in 2010 and 2011 with an office on Vitosha Blvd. - a former police station - offered the family D. and presented themselves under the name of Boyko Borisov and offered to buy these lands owned by the family D. at a price 9000 (nine

thousand) times below the market value, and after the members of the family D. refused to sell their lands, the National Revenue Agency and the prosecutor's office got involved, tax audits began, prosecutor Mariyana Stankova issued decrees for tax audits, and all properties of the D. family were seized, as well as the disputed lands of 2050 decares and 2170 decares.

The National Revenue Agency acted with extortion, blackmail, coercion, seeking unpaid taxes from the son of the M.D. family for 2,000,000 (two million) leva, 6,000,000 (six million) leva, 8,000,000 (eight million) leva, and the father D. was being sought for taxes in the amount of 2,000,000 (two million) leva, the mother 2,000,000 (two million) leva. Upon a complaint from a person representing himself as having the support of the GERB party and the DPS party, Krasimir Mollov, who is supported by Boyko Borisov and Delyan Peevski and Ahmet Dogan according to his words, a prosecutor's file was opened. There are also letters from the chairman of the Chamber of Private Enforcement Agents Georgi Saykov Dichev to the prosecutor's office, the National Revenue Agency, and the Sofia City Prosecutor's Office. In 2011 an arson attack was carried out on the apartment of the family D.; in 2012 at the beginning of the year a bus was waiting for M.D. at his office to hit and crush him, but only passed through his leg. In January 2012 a bus waited for 45 minutes for Momchil Dobrev in front of his office to ruin him. In September 2012 a criminal met Momchil Dobrev in the center of Sofia on Rakovski Street at a trolley stop in front of the office of the Commission for Fighting Corruption and Exposure to Corruption with cameras and others. Momchil Dobrev was carrying two bags in both hands with two laptops. The criminal Kalchev inflicted 14 blows with an umbrella handle on the left part of Momchil Dobrev's face and knocked out two of his teeth – which is average bodily injury. Momchil Dobrev pulled everything out and took a taxi.

In 2013 there were death threats from Is\$meil Poshti from Germany – with Chancellor Angela Merkel. Neither the prosecutor's office nor the Ministry of Interior investigated these attempts to assassinate him.

On 19.02.2020 was the next point for the murder of Momchil Dobrev on the 6th floor at 20:45 hours on G\$ME after a forgotten and forged court report by the judge of the Sofia City Court Raina Martinova and her chairman of the Sofia City Court Alexey Trifonov. After a few months the general of the mafia, General Lyuben Gotsev, called Momchil Dobrev to ask him for forgiveness because he and Boyko Borisov and Sotir Tsatsarov and the judges Raina Martinova and Alexey Trifonov are the orderers of the attempted murder of Momchil Dobrev on 19.02.2020.

On November 1, 2023, the attempt to murder Momchil Dobrev followed in the building of the Sofia District

Court with chairman Alexander Angelov in a court session with judge Lyubomir Ignatov - who was exceeding his power - and about which case you are informed, because a few months before, Momchil Dobrev brought a case under the RICO law against former prime minister Boyko Borisov, former chief prosecutor Sotir Tsatsarov, prosecutor Iliyan Iliev, the companies MIPK, PIMK Invest, PIMK OOD, and the companies Vodstroy 98 of Delyan Peevski and Hydrostroy with the participation of the companies Globul West and Metlatray D Engineering with manager Tsvete Borisova in the theft of 2.9 million cubic meters of earth mass from the private lands of the Dobrev Halachev Dynasty of the Principality of Dynasty Dobrev Halachev for zero cents, with which earth mass the northern tangent of Sofia was built.

We attach to you a complaint to the former chairmen of the Sofia City Court Svetlin Velkov Makhaylov - now a judge in the Sofia Appellate Court and judge Georgi Kolev - now a judge in the Supreme Administrative Court regarding the stolen cases part of the litigation we quote:

1. The case against Unicredit Bulbank for the stolen 15 million US dollars from my bank account in Biochim from 2010 has disappeared, proven stolen money by the NRA.
2. The case of an American company against "Bulgarian Posts" with an accepted accounting expertise for the obligation of "Bulgarian Posts" to this American company, which I am a manager of for over 36 digit number since 2006. Until now.
3. All cases filed for the declaration of bankruptcy of "Bulgarian Posts" for the above amount have disappeared.
4. All cases filed against the former judge of the Sofia City Court and her brother, lawyer Hristo Mollov, for the stolen slot machines and bingo equipment - my personal production of my company, which were found in the property of the two in the village of

Gorsko Novo Selo, have disappeared. And according to an accounting expertise in court cases, the losses caused in 2010 are over 29 million leva?

5. Have the cases against the prosecutor's office for my stolen slot machines by a special cop in Plovdiv, a special cop in Kyustendil, a special cop in Blagoevgrad, - hundreds of slot machines of my own production - a loss of over 49 million euros?
6. Have the cases for the stolen slot machines from Sabina Angelova worth over 9 million euros disappeared?

15. Disappeared cases for our properties in the center of Skopje case from 2007 terminated by Ivo Dachev, the property has already been resold to third parties and on the property and built: building business center?!? - loss according to accounting expertise of the court of 3 million leva?!?!
16. Disappeared cases against other banks for theft of money - bank guarantee and amounts of over 300 million United States dollars?!?!
17. Judge from Sofia City Court Lyubka Golakova is holding a case for our property in the center of Sofia, an inherited property with a total area of 11,890 sq.m. more than twelve years without a hearing, - already sold for the third time?! Real loss of over 400 million euros?!?!
18. Support - the double standards in Sofia City Courts and the double standard imposed by the following judges: judge Zgurov, judge Lyubka Golakova, judge Sheytanova, judge Raina Martinova, judge Albena Botevaya, judge Aleksandar Angelov, judge Claudia Mitova, judge Zlatka Choleva, Vasilena Dranchovska, who in some of our cases make self-dismisses and in other of our cases terminate them and issue court decisions that we lose property in the center of Sofia?!?!
19. Why don't you fulfill your obligations under art. 312 of the law on the armed forces and do not demand the immediate dismissal of a woman judge, Jaraina Martinova, who forged a court record from 60 minutes to 48 minutes with 17 manipulations on it, according to expertise in a criminal case in which he had an order to murder - confirmed by one of the perpetrators, General Lyuben Gotsev, my murder should have taken place on 19.02.2020?!?!
20. Imposing a double standard by the judge himself Rusi Aleksiev, Svetlin Velkov Mifaylov and Georgi Kolev after you recalled yourself in some of my cases and in a case related to this attempt to be at the order of Lyuben Gotsev, Boyko Borisov, Sotir Tzatzarov and judges from the Sofia City Court, you confirmed lawlessness and illegality and definitely in violation of judicial decisions of the European Court?!?!

Inaction of the political parties in the National Assembly – GERB, We Continue the Change, Yes Bulgaria, Movement for Rights and Freedoms, Vazrazhdane, There Are Such People – to change the banking law so that not only the Bulgarian National Bank opens insolvency procedures for banks but also companies and citizens – victims.

From the parliamentary groups in the National Assembly 2024 such as GERB with chairman former prime minister from 2009 to 2020 Boyko Borisov, the parliamentary group of We Continue the Change – Yes Bulgaria – Asen Vasilev, Kiril Petkov, Hristo Ivanov, Atanas Atanasov, the Vazrazhdane party with chairman Kostadin Kostadinov, the There Are Such People party with chairman Stanislav Strifonov, the Movement for Rights and Freedoms party with chairmen Delian Peevski and Dzhevdet Chakarov and honorary chairman Ahmet Dogan, a change of the Law on Banks and Credit Act has been requested in the direction of not only the Central Bank in the person of the Bulgarian National Bank to declare banks insolvent, but also individuals and companies affected by the actions of the banks.

No action followed by the deputies of all these parties, despite all the indisputable evidence of theft of money, violations of the laws of this country.

Another evidence that Bulgaria is controlled by the mafia, lawlessness, lawlessness of the state.

After complaints to all these political parties for their inaction for the caused damages, losses, missed benefits and profits, 14 times visits of two persons dressed in police uniforms to the house of Prince Lord Acad. Prof. Momchil Dobrev, who “policemen” carried photos of Momchil Dobrev and asked neighbors if Momchil Dobrev lives here.

A question followed from Prince Lord Acad. Prof.

Momchil Dobrev to the leaderships of all these parties – GERB with chairman Boyko Borisov, PP-DB, Asen Vassilev, Kiril Petkov, Risto Ivanov, Atanas Atanasov, DPS – Delyan Peevski and Dzhevdet Chakarov, There Is Such a People party – chairman Stanislav Trifonov, Vazrazhdane party – chairman Kostadin Kostadinov, Bulgarian Socialist Party – vice chairman Ninova and current Zafirov, whether they had sent these murderers for Momchil Dobrev, after Momchil Dobrev investigated that these were not any policemen.

7/. The inaction of the European Commission with chairman Barroso, then the European Commission with chairman Juncker and then Ursula von der Leyen at breakfast.

Complete inaction.

To the European Commission and the Federal Republic of Germany and France, to the European Commission President Ursula von der Layen, Rue dela Loi 200 / Wetstraat 200 1040 Bruxelles / Brussel, Belgique, to the Bundeskaznler der Bundesrepublik Deutschland – Olaf Scholz Bundesregierung, Willy-Brandt-Strasse 1 10557 – Berlin, Deutschland, to the President of France Mr. Emmanuel Macron, Palais de l'Elysee, 55 rue du Faubourg-Saint-Honore 75008 Paris, France, as the main countries in the European Commission have been presented with the sums of 31 trillion US dollars because they have not taken any measures against lawlessness and the mafia in the judicial system in Bulgaria, the lack of rule of law in Bulgaria, have not performed and activated monitoring and blocking of money by the European Commission to Bulgaria.

The European Commission, France and Germany have been charged with over 35 trillion US dollars for losses caused in connection with the inaction of these institutions for inspections, monitoring, and the appointment of measures and the imposition of monitoring and fines to Bulgaria in connection with the lawlessness, lawlessness, and failure to implement the laws in connection with the Law on Banks and Credit.

8/. Cases filed from 2004–2011 in Sofia City Court against the banks CBANK, Unicredit Bulbank, Postbank, Tokuda Bank, United Bulgarian Bank – disappeared in court.

From 2004 to 2011, claims were filed:

- Against Unicredit Bulbank for the amount of 340 million US dollars.
- Against Cbank for 5 million US dollars.
- Against Cbank for 150 million US dollars.
- Against Tokuda Bank AD – for 38 million euros.
- Against Postenska Bank for 500 million US dollars, and lost profits and profits of 1 billion US dollars.

- Against Raiffeisenbank for 15 billion US dollars, and lost profits and profits of another 15 billion US dollars.
- Later, cases were filed against United Bulgarian Bank (bank of KBS – Belgium) for the amount of 45 million US dollars.
- In the end, all cases against these banks have disappeared in the court system.

Since then, all these cases have disappeared in Sofia City Court – it is not known where they are, with which judge – nothing.

For this period, the chairmen of Sofia City Court were the judges Emil Markov, Judge Svetlin Mihaylov 2004–2009, criminal judge Georgi Kolev – chairman 2009–2010 – close to the GERB party with then prime minister Boyko Borisov then elevated to the chairman of the Supreme Administrative Court and elected by the Supreme Judicial Council, Judge Velichka Tsanova 2010–2011, Judge Vladimir Yaneva – chairman of the Sofia City Court for the period 2011–2015 – close to the GERB party then of the Prime Minister Boyko Borisov and the deputy chairman of the GERB party Tsvetan Tsvetanov, Judge Vladimir Yordanov – chairman acting as chairman for the period 26.02.2015–07.07.2013, Judge Kaloyan Topalov – chairman of the Sofia City Court for the period 07.07.2015–29.09.2017, Judge Desislava Popkoleva – chairman of the Sofia City Court for the period 2017–2019, Judge Alexey Trifonov – chairman of the Sofia City Court 2019–2024 – born in the Soviet Union and it was not actually proven that he renounced his Russian citizenship and actually in violation – close to the GERB party and the MRF of Ahmet Dogan, deputy chairmen Rusi Alexie, Stefan Kurkchie, Raina Tefanova, Stella Katsarova, deputies, deputies Albena Boteva, deputy Popkoleva.

Although all these chairmen of the Sofia City Court have been notified of the pending cases, no one took any action to find these cases.

The chairmen of the Sofia Court of Appeal for this period were also notified of the pending cases, namely SAS Pengezov (2009), Daniela Doncheva (from 5 May 2016 to date, including her second term), and Ivo Dachev (deputy), to take the appropriate administrative measures. No measures have been taken by these chairmen of the Sofia Court of Appeal.

All claimed amounts are accepted on balance and on issued invoices and are never objected or disputed by all of these institutions.

In addition, based on the mafia and mafiotism and the inactivity of the European Commission, France and Germany as the most important member states of the European Commission, claims have been made. And on the accepted balance and issued invoices, the three institutions have obligated to pay the companies of Prince Lord Academician Prof. Momchil Dobrev the sum of 135 trillion euros, for all thefts of assets of “Dynasty Dobrev Halachev” and “Principality of Dynasty Dobrev Halachev”.

15/. For more than two years, a response has been waiting from the UN Human Rights Council in Geneva!! Will it also serve the mafia in Bulgaria?!?!

16. As a result of the RICO Act case in the USA, several attempts to assassinate Prince Lord Academician Prof. Momchil Dobrev followed

On October 30, 2023, before the court hearing in the case of Prince Lord Academician Prof. Momchil Dobrev in the Sofia District Court, he was warned by a colonel from counterintelligence that on November 1, 2023, Dobrev would be killed in the building of the Sofia District Court, just as the person Plamen Penev was killed in Stara Zagora during detention with his head pressed to the edge of the sidewalk, as for Momchil Dobrev it would happen in the building of the Sofia District Court when he was held on the edge of the wooden bench on the second floor of the building, with the participation of judges, police officers and others on November 1, 2023 in the building of the Sofia District Court - Tsar Boris Blvd. 3 No. 52-54.

On November 1, 2023, Lord Prof. Momchil Dobrev has a court hearing against the Sofia Court of Appeal because Judge Neli Kutskova abused her official position and, although she was taken to Momchil Dobrev's case against a construction company for losses of over 500,000 euros, she does not recuse herself but confirms the replacement of security of a forbidden lot of Momchil Dobrev's debtor - a construction company that has not returned his money since 21.12.2007. Replacement of the security property for only 2500 euros - i.e. Momchil Dobrev is guaranteed a loss of over 500,000 euros, since the construction company after this act has no property and the non-return of the money and the non-transfer of property by the construction company has been proven by the prosecutor's office. I.e. the case is about the fact that Judge Neli Kutskova has confirmed the illegal actions of replacement of the security - property of the debtor by Judge Raina Martinova from Sofia City Court, who also participated in the tenth attempt to murder Momchil Dobrev.

Judge Lyubomir Ignatov, the judge in the case, is again asking for Momchil Dobrev's ID card, as before, in a previous court hearing, he illegally wrote down Momchil Dobrev's ID card in the minutes of the court hearing and this is what really happened access to Momchil Dobrev's personal data in Yala Bulgaria, which resulted in attempts to steal Momchil Dobrev's companies.

Momchil Dobrev refuses to give his ID card, especially since he had changed his ID card at the police station a few days before. Immediately, Judge Lyubomir Ignatov picks up the phone and calls the court security. Momchil Dobrev understands what is being prepared and that he will be killed accidentally during this detention and immediately takes measures to leave the Sofia District Court building, stopping 7 meters after leaving the court building. He is attacked by 5 police officers who start to squeeze his arms and body and force him into a courtroom on the second floor to continue the case in which Momchil Dobrev is a plaintiff. 5 police officers

guard him in the hall. In front of the courtroom, 4 more police officers challenge him, but Momchil Dobrev remains completely calm for two hours and 54 minutes while the court session is taking place with the participation of a prosecutor, for whom this behavior of Judge Lyubomir Ignatov is not illegal.

After the court session, Momchil Dobrev asks for the recordings from the cameras inside the court and outside the court from the ministers, Assoc. Prof. Atanas Slavov, the minister, the former criminal judge with property in Greece, Dechev, and has notified both the acting chief prosecutor Borislav Sarafov, the presidents of the Sofia City Court, Judge Aleksey Trifonov, and Judge Aleksandar Angelov - president of the Sofia District Court.

There is no reaction, no compliance with the laws, no investigation. There are not even any actions by all members of the Supreme Judicial Council against Judge Lyubomir Ignatov.

This seventeenth assassination attempt took place after on 19.02.2020, based on a false court report prepared by Judge Raina Martinova from the Sofia City Court, it did not take place, again on behalf of the mafia, with the participation of the mafia boss, statesman, judges and prosecutors, after the ninth murder attempt on 19.02.2020 in the GM building at 20.45, on behalf of the mafia boss General Lyuben Gotsev, according to the words of the deputy chief of the SDVR - Boyko Borisov, the prosecutors of Sotir Tsatsarov, through the judges Alexei Trifonov on the basis of a false court report prepared by Judge Raina Martinova from a court session on 22.11.2019 prepared by Judge Raina Martinova from Sofia City Court recording of 60 minutes became only 48 minutes with 17 /seventeen/ manipulations of the recording proven by expert reports did not happen, again on the orders of the mafia, with the participation of the mafia boss, statesman, judges and prosecutors, after the first attempt to murder Momchil Dobrev - 2011 with the arson of the apartment where I live where they were going to burn his mother and father who was bedded from 2008 after the death threats from a statesman who demanded that the Dobrevi family - Dobrev Halachev dynasty give their properties to him because as mayor of BB in 2008 he stated that the relevant lands were his, 2012 when bus trying to defeat Momchil Dobrev and other attempts to murder me to him and his wife.

Since in the article we will discuss the financial system according to the theory and practice of the **first basic law for mastering a state**:

Mastering the financial system of this state.

1/. Mastering the financial system

Banks are sold to banking institutions close to mafia fascism.

Unwritten law of these banks – failure to comply with the laws of the state.

- Failure to implement state laws.
- Failure to implement laws – in the case of the banking and credit law.
- Separate control of the structures that should control banks.
- In this case – control of the central bank.
- It is well known that one family controls 178 central banks all over the world.
- Control of the central bank with the central bank law.
- Full dependence of the central bank's decisions on the structure that manages it – the structures close to mafia fascism.
- On the one hand, the central bank and its bodies do not implement the law on banks and credit and do not...
- The central bank does not sanction a bank that has violated the law if it belongs to the mafia.
- The central bank does not revoke a license even in the case of gross violations if this bank belongs to the mafia.
- The central bank does not revoke a bank's license in the case of:
 - Theft by its bank of money from citizens and companies – even in tens of millions
 - An unauthorized third party transferring a huge amount to a third party close to him and dewatering a bank account
 - Dewatering bank accounts by third parties

- Dewatering bank accounts by third parties
- Illegal transfers
- Illegal theft of money
- Delaying payment of money to a deceased person to his heirs
- Theft of money from bank accounts of individuals
- Theft of money from bank accounts of companies
- Non-revocation of the bank's license for the above violations

Control of the financial system is guaranteed by a controlled judicial system – court, prosecutor's office – so that citizens and companies that have suffered from crimes committed by banks and their employees are not sanctioned, nor are charges brought against them.

Separately from this, even those who have continued to bring cases cannot make the cases win – or the cases disappear for ten years in courts, like the cases of Prince Lord Academic Professor Momchil Dobrev have disappeared since 2008, the cases against CBank – the bank of the close friend of Minister President Boiko Borisov, Tsvetelina Borislavova.

Money was illegally stolen from an American company from a special bank account, an illegal transfer by a third party not authorized to do so, a seizure of a special account on which tens of millions of US dollars were expected to be transferred, with the purpose of theft of this money, without a court order, only by order of the supervisory board of this bank – Tsvetelina Borislavova.

The seizure is for 50 million leva, illegally. This fails a deal for 5 billion US dollars and causes the loss of this money and many more missed benefits and profits.

Control of the body that should control the banks.

- In this case, this is the central bank.
- People close to those who run the deep mafia are appointed.
- Who carry out orders of the mafia.

Imposing double standards

Provided that a bank seeks help from the state due to deficiencies in its banking liquidity, it does not receive any help, while another bank whose owners are from the mafia immediately receives state aid – millions without term, without interest, without any conditions.

That is, even when creating a reason for bankruptcy of a given banking institution, the goal is for it to be robbed by people close to the government.

Creating a condition for theft of the assets of a given bank.

The same applies to the prosecutor's office.

With every complaint about stolen money, illegally transferred large sums by a third party who was not authorized – and there is actually a theft of money – if the bank serves the mafia, there is no settlement against that bank or its employees.

Ultimately, there are no charges brought against the persons who carried out the theft of the money.

Steps for this control:

- 1/. Appointment of judges loyal to the mafia in the court
- 2/. Appointment of prosecutors loyal to the mafia in the prosecutor's office
- 3/. Control of the prosecutor's office and control of the investigation
- 4/. Control of the Ministry of Justice
- 5/. Control of controlling bodies in the judicial system – for example, for Bulgaria – the Inspectorate to the Higher Judicial Council
- 6/. Control of the institution that appoints judges and prosecutors – the Higher Judicial Council – on the example of Bulgaria

18.4./ Control of the judicial system. Control of the court, control of the prosecutor's office, control of the investigation, control of private judicial enforcement

- Control is achieved by appointing judges, prosecutors, investigators close to the mafia as heads of courts, of the prosecutor's office, the prosecutor general, and the heads of regional, city, and district prosecutor's offices.
- Control of the judicial body – the Supreme Judicial Council.
- Control of the inspector to the judicial body – the Inspectorate to the Supreme Judicial Council.
- Control of the Constitutional Court – appointment of constitutional judges close to the party oligarchy who carry out orders of the mafia.
- Control of the courts through the chairman of the Supreme Court of Cassation; the courts of appeal in Sofia, Plovdiv, Veliko Tarnovo, Varna, and Burgas; control of the largest district court – Sofia City Court – by appointing judges loyal and close to the mafia.
- Appointment of chairmen of courts close to the mafia and the oligarchy, who will unconditionally carry out orders of the mafia – to terminate cases, to lose cases against the mafia.
- Mastering the system for appointing judges – ignoring and bypassing the electronic random selection system, as deputy chairmen of courts appoint a specific judge for a specific case, who will carry out the order of the mafia and the oligarchy.
- Mastering the system for appointing judges for cases in the Supreme Court of Cassation – by appointing chairmen close to the mafia and deputy chairmen to assign specific cases to specific judges who will carry out the mafia's order.

- Mastering the system for appointing judges in the Supreme Administrative Court – in the same manner.
- Creation of administrative courts to protect and legalize crimes committed by ministers, officials, state agencies, ministries, and others against citizens and companies.
- Creation of administrative courts to legalize repression carried out by the mafia through institutions such as the National Revenue Agency.

Appointment of mafia-aligned presidents of courts, through which courts will:

- Legalize theft of private property by the mafia and oligarchy
- Legalize theft of money from mafia-controlled banks
- Indicate failure to comply with laws by banks serving the mafia
- Legalize failure to comply with laws by insurance companies serving the mafia

Creation of new norms – “unwritten laws” – new norms – new standards in court, prosecutor's office, state, in benefit of the mafia

- Creation of unwritten laws on enforcement of laws – double and triple standards by judges, prosecutors, statesmen.
- Creation of unwritten laws on application of laws – double and triple standards.
- Creation of unwritten laws on reading of laws – double and triple standards.
- Creation of double and triple standards in court and prosecutor's office, which contradict the law, its implementation, and its application by judges, prosecutors, private bailiffs, ministers, inspectors, and members of the Supreme Judicial Council.
- Law on the double standard regarding laws – disregard, non-observance, non-application of the law by the judge or prosecutor, not as the law orders, but as he wants or as ordered by a mafia client.
- Law on the double standard regarding morality and ethics of the judge – when a judge recuses himself in one case but not in another with the same plaintiff.
- Double standard law – intentional manipulation of claim value to prevent appeal.
- Double standard law – termination of lawsuits against banks, insurance companies, companies, ministries, state commissions, and institutions.
- Double standard law regarding issuance of decisions.
- Double standard law – judges are not responsible for the decisions they make.

Creation of a system for enforcing double standards and schemes – the norm of the neoliberal neofascist

mafia of lawlessness and genocide of law among judges

- Creation of a system for supporting these war standards.
- Creation of a system for guaranteeing these double standards by the body that should control the judicial system – e.g., the Higher Judicial Council in Bulgaria.
- Appointment of persons close to the mafia in the Higher Judicial Council, who disregard laws and guarantee mafia influence.
- The mafiotisation of the judicial system of Bulgaria and its support by the European Union, the Commission, and the USA with presidents Obama, Trump, Joe Biden.
- Creation of a system for repression and harassment through the judicial system against people who fight the mafia.
- Creation of a system for fabricating criminal cases against such persons.
- Creation of schemes for imprisonment of such persons.
- Creation of schemes for fabricating false documents with the purpose of forming criminal cases.
- Creation of schemes for preparing false expertises.
- Creation of schemes for organizing murder of those fighting the mafia.
- Creation of schemes for reprisals via the National Revenue Agency – fabrication of documents claiming undue taxes.
- Creation of schemes for conviction on the basis of forgeries and fraud.

Corruption of the judicial system

- Corruption of the court.
- Corruption of the prosecutor's office.
- Corruption of the investigation.
- Corruption of the police.
- Corruption of the National Revenue Agency.
- Creation of a system of connections and contacts at all levels of administration.

Creation of a system for stimulating judges from the mafia:

- Promotion in rank
- Appointment to the European Court of Human Rights
- Appointment to OLAF
- Appointment to international legal bodies
- Appointment to the Venice Commission

19. CONCLUSION

The described specific cases prove the mafia fascism of the US-dominated country Bulgaria, the genocide of law,

justice, justice and its mafiotisation – there is no rule of law in Bulgaria.

This mafia has been reported to both the European Union and the European Commission, but also to the German chancellors Merkel and Scholz, the French president Macron, and the British prime ministers when the country was part of the European Union, as well as to the US presidents Obama, Trump, and Joe Biden.

There was no reaction, no compliance with the laws of the Treaty on the European Community, which proves the support of this neoliberal neofascist deep mafia in Bulgaria by the USA and the European Union – and a commission chaired by Barroso, Jean-Claude Juncker, and Ursula von der Leyen. Clearly the USA and the European Commission and the European Union are interested in this mafia and this lawlessness in the Republic of Bulgaria.

That is why there are claims for damages of over 135 trillion USD accepted on balance and invoices.

The mafia has its own state – Bulgaria!!!!
